"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms and gas ejecting devices; to prohibit the buying, selling, or carrying of certain firearms and gas ejecting devices without a license; to provide for the forfeiture of firearms possessed in violation of this act; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; and to repeal all acts and parts of acts inconsistent with the provisions of this act,"

(MCL 28.421 to 28.434) by adding section 5p.

- 3 PISTOL SHALL PAY A FEE OF \$5.00. THE FEE SHALL BE PAYABLE TO THE
- 4 COUNTY. THE COUNTY TREASURER SHALL DEPOSIT THE FEE IN A CON-
- 5 CEALED WEAPON AWARENESS FUND FOR THE COUNTY. THESE FUNDS SHALL
- 6 BE USED ONLY FOR THE PURPOSES DESCRIBED IN SUBSECTION (2).
