April 22, 1998, Introduced by Senator BERRYMAN and referred to the Committee on Appropriations.

A bill to amend 1957 PA 261, entitled "Michigan legislative retirement system act," (MCL 38.1001 to 38.1080) by adding section 23a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 23A. (1) THE RETIREMENT ALLOWANCE OF A RETIRANT WHO 2 RETIRES UNDER THIS ACT ON OR AFTER THE EFFECTIVE DATE OF THIS 3 SECTION SHALL BE SUSPENDED IF THE RETIRANT BECOMES A MEMBER OF 4 ANY OTHER PUBLIC EMPLOYEE RETIREMENT SYSTEM BY VIRTUE OF HOLDING 5 ELECTIVE OFFICE. THE BOARD SHALL SUSPEND THE RETIREMENT ALLOW-6 ANCE EFFECTIVE THE FIRST DAY OF THE MONTH IMMEDIATELY FOLLOWING 7 THE MONTH IN WHICH THE RETIRANT BECOMES A MEMBER OF THE PUBLIC 8 EMPLOYEE RETIREMENT SYSTEM BY VIRTUE OF HOLDING ELECTIVE OFFICE. 9 THE BOARD SHALL NOT BEGIN PAYMENT OF A RETIREMENT ALLOWANCE TO A 10 DEFERRED VESTED MEMBER WHILE THAT DEFERRED VESTED MEMBER IS A
