THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 811D. (1) THE SECRETARY OF STATE SHALL DEVELOP AND,
- 2 UPON APPLICATION, MAY ISSUE A CRITICAL WILDLIFE HABITAT REGISTRA-
- 3 TION PLATE TO AN APPLICANT FOR USE ON THE PASSENGER MOTOR VEHI-
- 4 CLE, PICKUP TRUCK, VAN, MOTOR HOME, HEARSE, BUS, TRAILER COACH,
- 5 OR TRAILER FOR WHICH THE REGISTRATION PLATE IS ISSUED INSTEAD OF
- 6 A STANDARD REGISTRATION PLATE. CRITICAL WILDLIFE HABITAT REGIS-
- 7 TRATION PLATES SHALL BEAR LETTERS AND NUMBERS THAT THE SECRETARY
- 8 OF STATE PRESCRIBES. THE PLATE SHALL BE OF A DESIGN AS DETER-
- 9 MINED BY THE SECRETARY OF STATE. THE WORD "MICHIGAN" SHALL
- 10 APPEAR ON EACH CRITICAL WILDLIFE HABITAT REGISTRATION PLATE.

- 7 PLATES, THE SECRETARY OF STATE SHALL ON A QUARTERLY BASIS TRANS-
- 8 FER THE BALANCE OF THE CRITICAL WILDLIFE HABITAT REGISTRATION
- 9 PLATE SERVICE FEES TO THE STATE TREASURER, WHO SHALL CREDIT THE
- 10 FEE MONEY TO THE NONGAME FISH AND WILDLIFE TRUST FUND CREATED
- 11 UNDER SECTION 43902 OF THE NATURAL RESOURCES AND ENVIRONMENTAL
- 12 PROTECTION ACT, 1994 PA 451, MCL 324.43902, FOR THE PURCHASE AND
- 13 DEVELOPMENT OF CRITICAL WILDLIFE HABITATS IN THIS STATE.
- 14 (6) FOR PURPOSES OF THIS SECTION, "CRITICAL WILDLIFE HABITAT
- 15 REGISTRATION PLATE" MEANS A REGISTRATION PLATE CONTAINING A SPE-
- 16 CIALIZED DESIGN PERTAINING TO THE CRITICAL WILDLIFE HABITATS OF
