## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 438. (1) BEGINNING FOR THE 1998 TAX YEAR AND UNTIL THE
- 2 STATE TREASURER CERTIFIES THAT THE ASSETS IN THE ORGAN DONOR EDU-
- 3 CATION FUND CREATED IN THE ORGAN DONOR EDUCATION FUND ACT EXCEED
- 4 \$5,000,000.00, A TAXPAYER MAY DESIGNATE ON HIS OR HER ANNUAL
- 5 RETURN THAT A CONTRIBUTION OF \$2.00 OR MORE OF HIS OR HER REFUND
- 6 BE CREDITED TO THE ORGAN DONOR EDUCATION FUND CREATED IN THE
- 7 ORGAN DONOR EDUCATION FUND ACT. IF A TAXPAYER'S REFUND IS NOT
- 8 SUFFICIENT TO MAKE A CONTRIBUTION UNDER THIS SECTION, THE TAX-
- 9 PAYER MAY DESIGNATE A CONTRIBUTION AMOUNT AND THAT CONTRIBUTION
- 10 AMOUNT SHALL BE ADDED TO THE TAXPAYER'S TAX LIABILITY FOR THE TAX
