## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 507. (1) ALL BILLINGS BY A TELECOMMUNICATIONS PROVIDER
- 2 SHALL BE WRITTEN IN A CLEAR AND CONSPICUOUS MANNER AND PROVIDE
- 3 THE NECESSARY INFORMATION TO ALLOW AN END-USER TO MAKE INFORMED
- 4 DECISIONS REGARDING THEIR SERVICES AND SERVICE PROVIDERS.
- 5 (2) ALL BILLINGS SHALL BE CLEARLY ORGANIZED AND SHALL
- 6 INCLUDE, BUT NOT BE LIMITED TO, ALL OF THE FOLLOWING:
- 7 (A) IDENTIFICATION OF ANY NEW CHARGES OR CHANGES TO THE
- 8 END-USER'S SERVICES FROM THE PREVIOUS BILLING PERIOD.
- 9 (B) COMPLETE DESCRIPTIONS OF ALL CHARGES AND THE SERVICE
- 10 PROVIDER RESPONSIBLE FOR EACH CHARGE, INCLUDING THE PROVIDER'S
- 11 ADDRESS AND TOLL-FREE TELEPHONE NUMBER.

- 24 PERSON THAT PROVIDES 1 OR MORE TELECOMMUNICATIONS SERVICES FOR
