## SUBSTITUTE FOR HOUSE BILL NO. 4928

(As amended October 28, 1999)

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending section 909 (MCL 257.909).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 909. (1) [A EXCEPT AS PROVIDED IN SUBSECTION (2), A] civil fine which is ordered under section
- 2 907 for a violation of this act or other state statute OR FOR A
- 3 VIOLATION OF A CODE OR AN ORDINANCE OF A POLITICAL SUBDIVISION OF
- 4 THIS STATE REGULATING COMMERCIAL MOTOR VEHICLES AND SUBSTANTIALLY
- 5 CORRESPONDING TO A PROVISION OF THIS ACT shall be exclusively
- 6 applied to the support of public libraries and county law librar-
- 7 ies in the same manner as is provided by law for penal fines
- 8 assessed and collected for violation of a penal law of the
- 9 state. [A CIVIL FINE ORDERED FOR A VIOLATION OF A CODE OR ORDINANCE OF A POLITICAL SUBDIVISION OF THIS STATE REGULATING COMMERCIAL MOTOR VEHICLES AND SUBSTANTIALLY CORRESPONDING TO A PROVISION OF THIS ACT SHALL BE ALLOCATED AS FOLLOWS:
  - (A) THIRTY PERCENT TO THE CITY, VILLAGE, OR COUNTY FOR REPAIR AND MAINTENANCE ON LOCAL ROADS. IF THE CITATION IS ISSUED UNDER TOWNSHIP ORDINANCE, THE COUNTY SHALL ALLOCATE THE FUNDS FOR REPAIR AND MAINTENANCE ON LOCAL ROADS WITHIN THAT TOWNSHIP.
  - (B) FORTY PERCENT TO THE JURISDICTION IN WHICH THE CITATION WAS ISSUED FOR LIBRARY PURPOSES AS PROVIDED BY LAW.
  - (C) THIRTY PERCENT TO THE COURT FUNDING UNIT IN WHICH THE POLITICAL SUBDIVISION IS LOCATED.
  - (2) SUBSECTION (1) DOES NOT APPLY TO A CIVIL FINE ORDERED FOR A VIOLATION OF A CODE OR ORDINANCE OF A POLITICAL SUBDIVISION OF THIS STATE SERVED BY A MUNICIPAL COURT.]
- 10 [(3)] Subsection (1) is intended to maintain a source of
- 11 revenue for public libraries which previously received penal
