SUBSTITUTE FOR SENATE BILL NO. 106

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending section 535a (MCL 750.535a), as amended by 1988 PA 140.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 535a. (1) As used in this section:
- 2 (a) "Bona fide purchaser for value" means a person who pur-
- 3 chases property for value in good faith and without notice of any
- 4 adverse claim to the property.
- 5 (b) "Chop shop" means any OF THE FOLLOWING:
- 6 (i) ANY area, building, storage lot, field, or $\frac{}{}$ other
- 7 premises or place where 1 or more persons are engaged or have
- 8 engaged in altering, dismantling, reassembling, or in any way
- 9 concealing or disguising the identity of a stolen motor vehicle

- 1 or of any major component part of a stolen motor vehicle. ; or
- 2 any
- 3 (ii) ANY area, building, storage lot, field, or any other
- 4 premises or place where there are 3 or more stolen motor vehicles
- 5 present or where there are major component parts from 3 or more
- 6 stolen motor vehicles present.
- 7 (c) "Major component part" means 1 of the following parts of
- 8 a motor vehicle:
- 9 (i) The engine.
- 10 (ii) The transmission.
- 11 (iii) The right or left front fender.
- 12 (iv) The hood.
- (v) A door allowing entrance to or egress from the passenger
- 14 compartment of the vehicle.
- 15 (vi) The front or rear bumper.
- 16 (vii) The right or left rear quarter panel.
- 17 (viii) The deck lid, tailgate, or hatchback.
- 18 (ix) The trunk floor pan.
- 19 (x) The cargo box of a pickup.
- 20 (xi) The frame, or if the vehicle has a unitized body, the
- 21 supporting structure or structures -which THAT serve as the
- 22 frame.
- 23 (xii) The cab of a truck.
- 24 (xiii) The body of a passenger vehicle.
- 25 (xiv) AN AIRBAG OR AIRBAG ASSEMBLY.
- 26 (xv) A WHEEL OR TIRE.

- 1 (xvi) $\overline{(xiv)}$ Any other part of a motor vehicle $\overline{\text{which}}$ THAT
- 2 the secretary of state determines is comparable in design or
- $\bf 3$ function to any of the parts listed in subparagraphs (i) to
- 4 (xiii) (xv).
- 5 (d) "Motor vehicle" means a EITHER OF THE FOLLOWING:
- 6 (i) A device in, upon, or by which a person or property is
- 7 or may be transported or drawn upon a highway that is
- 8 self-propelled or that may be connected to and towed by a
- 9 self-propelled device. , and a
- 10 (ii) A land-based device that is self-propelled but is not
- 11 designed for use upon a highway, including, but not limited to,
- 12 farm machinery, a bulldozer, -and OR a steam shovel.
- 13 (2) Except as provided in subsection (3), a person who know-
- 14 ingly owns, operates, or conducts a chop shop or who knowingly
- 15 aids and abets another person in owning, operating, or conducting
- 16 a chop shop is guilty of a felony —, punishable by imprisonment
- 17 for not more than $\frac{-5}{}$ 10 years $\frac{-}{}$ or $\frac{-by}{}$ a fine of not more
- 18 than $\frac{$5,000.00}{$250,000.00}$, or both.
- 19 (3) Upon a second or subsequent conviction under this sec-
- 20 tion, the person convicted may be imprisoned for not more than
- 21 -5 10 years and shall be fined not less than \$10,000.00 OR MORE
- 22 THAN \$250,000.00, OR BOTH.
- 23 (4) A person who violates IN ADDITION TO ANY OTHER PUNISH-
- 24 MENT, A PERSON CONVICTED OF VIOLATING this section -, upon con-
- 25 viction, in addition to any other punishment, may SHALL be
- 26 ordered to make restitution to the rightful owner of a stolen
- 27 motor vehicle or of a stolen major component part, or to the

1 owner's insurer if the owner has already been compensated for the

- 2 loss by the insurer, for any financial loss sustained as a result
- 3 of the theft of the motor vehicle or a major component part.
- 4 Restitution -may SHALL be imposed in addition to, but not
- 5 instead of, any imprisonment or fine imposed.
- 6 (5) All of the following are subject to seizure and, if a
- 7 person is charged with a violation or attempted violation of sub-
- 8 section (2) and is convicted of a violation or attempted viola-
- 9 tion of subsection (2) or section 415, 416, 535, or 536a, all of
- 10 the following are subject to forfeiture:
- 11 (a) An engine, tool, machine, implement, device, chemical,
- 12 or substance used or designed for altering, dismantling, reassem-
- 13 bling, or in any other way concealing or disguising the identity
- 14 of a stolen motor vehicle or any major component part.
- 15 (b) A stolen motor vehicle or major component part found at
- 16 the site of a chop shop or a motor vehicle or major component
- 17 part for which there is probable cause to believe that it is
- 18 stolen.
- 19 (c) A wrecker, car hauler, or any other motor vehicle that
- 20 is used or has been used to convey or transport a stolen motor
- 21 vehicle or major component part.
- 22 (d) Books, records ANY BOOK, RECORD, money, negotiable
- 23 instruments INSTRUMENT, or other personal property or real
- 24 property, except real property that is the primary residence of
- 25 the spouse or a dependent child of the owner, that is or has been
- 26 used in a chop shop operation.

1 (6) Except as provided in subsection (7), property described

- 2 in subsection (5) may be seized by a state or local law
- 3 enforcement agency upon process issued by the recorder's court of
- 4 the city of Detroit or the district or circuit court having
- 5 jurisdiction over the property. Seizure without process may be
- 6 made in any of the following cases:
- 7 (a) The seizure is incident to an arrest or pursuant to a
- 8 search warrant or an inspection under an administrative inspec-
- 9 tion warrant.
- 10 (b) The property subject to seizure has been the subject of
- 11 a prior judgment in favor of this state in a forfeiture proceed-
- 12 ing based upon this section.
- 13 (c) Exigent circumstances exist that preclude the obtain-
- 14 ing of process and there is probable cause to believe that the
- 15 property was used or is intended to be used in violation of this
- 16 section.
- 17 (7) In order to retain, pending the forfeiture hearing, TO
- 18 RETAIN property for which seizure and forfeiture is ARE sought
- 19 under this section PENDING THE FORFEITURE HEARING, a licensed
- 20 used or secondhand vehicle parts dealer or the owner may post a
- 21 bond in the amount of 1-1/2 times the value of the property.
- 22 This subsection does not apply to a motor vehicle or major compo-
- 23 nent part that is to be used as evidence in a criminal
- 24 proceeding.
- 25 (8) In the event of a seizure of IF property other than
- 26 real property pursuant to IS SEIZED UNDER subsection (6), the

- 1 seizing law enforcement agency shall do 1 or more of the
- 2 following, subject to subsection (9):
- 3 (a) Place the property under seal.
- 4 (b) Remove the property to a designated storage area.
- 5 (c) Petition the recorder's court of the city of Detroit or
- 6 the district or circuit court to appoint a custodian to take cus-
- 7 tody of the property and to remove it to an appropriate location
- 8 for disposition in accordance with law.
- 9 (9) If property is seized without process under
- 10 subsection (6), within 14 days after the seizure, the seizing
- 11 agency shall return the property to the person from whom it was
- 12 seized unless a hearing has been scheduled to determine whether
- 13 the seizure was proper and reasonable notice of the hearing has
- 14 been given.
- 15 (10) The rightful owner of any property THAT IS TO BE
- 16 FORFEITED under subsection (5) that is to be forfeited shall be
- 17 served notice at least 10 days before the matter is to be heard
- 18 regarding the forfeiture and, if the rightful owner did not
- 19 know of and did not consent to the commission of the crime, the
- 20 property shall be returned to the rightful owner. If the right-
- 21 ful owner of the property is not known or cannot be found, notice
- 22 may be served by publishing notice of the forfeiture hearing not
- 23 less than 10 days before the date of the hearing in a newspaper
- 24 of general circulation in the county where the hearing is to be
- 25 held. The notice shall contain a general description of the
- 26 property and any serial or registration numbers on the property.

- (11) A forfeiture of property encumbered by a bona fide
- 2 security interest is subject to the interest of the secured party
- 3 who -neither had knowledge of nor consented DID NOT KNOW OF OR
- 4 CONSENT to the act or omission in violation of this section.
- (12) Any property seized under subsection (6) that was 5
- 6 stolen shall be returned to its rightful owner if that ownership
- 7 can be established to the satisfaction of the seizing law
- 8 enforcement agency. Any stolen property that is unclaimed after
- 9 seizure may be sold pursuant to AS PROVIDED BY law.
- (13) Any property forfeited under this section may be sold 10
- 11 pursuant to an order of the court. The proceeds of the sale
- 12 shall be distributed by the court having jurisdiction over the
- 13 forfeiture proceeding to the entity having budgetary authority
- 14 over the seizing law enforcement agency. If more than 1 law
- 15 enforcement agency was substantially involved in effecting the
- 16 forfeiture, the court having jurisdiction over the forfeiture
- 17 proceeding shall distribute equitably the proceeds of the sale
- 18 among the entities having budgetary authority over the seizing
- 19 law enforcement agencies. Twenty-five percent of the money
- 20 received by an entity under this subsection shall be used to
- 21 enhance law enforcement efforts pertaining to this section.
- (14) This section does not apply to a person who is a bona 22
- 23 fide purchaser for value of the motor vehicle or major component
- 24 parts described in subsection (1).
- 25 Enacting section 1. This amendatory act takes effect April
- **26** 1, 2000.
