- 1 SEC. 1284B. (1) FOR THE 1999-2000, 2000-2001, AND 2001-2002
- 2 SCHOOL YEARS, THE BOARD OF A SCHOOL DISTRICT, LOCAL ACT SCHOOL
- 3 DISTRICT, PUBLIC SCHOOL ACADEMY, OR INTERMEDIATE SCHOOL DISTRICT
- 4 SHALL ENSURE THAT THE DISTRICT'S OR PUBLIC SCHOOL ACADEMY'S
- 5 SCHOOLS ARE NOT IN SESSION ON THE FRIDAY BEFORE LABOR DAY. AS
- 6 USED IN THIS SECTION, "LABOR DAY" MEANS THE FIRST MONDAY IN
- 7 SEPTEMBER.
- 8 (2) THE SCHOOL CALENDAR TASK FORCE IS CREATED AS A TEMPORARY
- 9 COMMISSION DESCRIBED IN SECTION 4 OF ARTICLE V OF THE STATE
- 10 CONSTITUTION OF 1963. THE SCHOOL CALENDAR TASK FORCE SHALL STUDY
- 11 THE ISSUES SPECIFIED IN THIS SUBSECTION CONCERNING THE PUBLIC

- 20 TED BY THE PRESIDENT OF THE MICHIGAN STRATEGIC FUND.
- 21 (D) ONE MEMBER REPRESENTING THE MICHIGAN TRAVEL COMMISSION,
- 22 APPOINTED FROM AMONG NOMINATIONS SUBMITTED BY THE MICHIGAN TRAVEL
- 23 COMMISSION.
- 24 (E) ONE MEMBER REPRESENTING THE GENERAL PUBLIC.
- 25 (F) ONE MEMBER WHO IS A K-12 TEACHER IN THIS STATE,
- 26 APPOINTED FROM AMONG NOMINATIONS JOINTLY SUBMITTED BY THE

- 1 MICHIGAN EDUCATION ASSOCIATION AND THE MICHIGAN FEDERATION OF
- 2 TEACHERS.
- 3 (G) ONE MEMBER WHO IS NOMINATED BY THE MICHIGAN CHAMBER OF
- 4 COMMERCE.
- 5 (4) THE MEMBERS APPOINTED TO THE SCHOOL CALENDAR TASK FORCE
- 6 SHALL BE APPOINTED NOT LATER THAN JULY 1, 1999.
- 7 (5) MEMBERS OF THE SCHOOL CALENDAR TASK FORCE SHALL SERVE
- 8 UNTIL THE TASK FORCE FINDINGS ARE REPORTED AS REQUIRED UNDER
- 9 SUBSECTION (2).
- 10 (6) IF A VACANCY OCCURS ON THE SCHOOL CALENDAR TASK FORCE,
- 11 THE GOVERNOR SHALL APPOINT A REPLACEMENT IN THE SAME MANNER AS

- 16 CHAIRPERSON AND OTHER OFFICERS AS IT CONSIDERS NECESSARY OR

- (10) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF,
- 2 OR RETAINED BY THE SCHOOL CALENDAR TASK FORCE IN THE PERFORMANCE
- 3 OF AN OFFICIAL FUNCTION IS SUBJECT TO THE FREEDOM OF INFORMATION
- 4 ACT, 1976 PA 442, MCL 15.231 TO 15.246.
- 5 (11) MEMBERS OF THE SCHOOL CALENDAR TASK FORCE SHALL SERVE
- 6 WITHOUT COMPENSATION. HOWEVER, MEMBERS OF THE TASK FORCE MAY BE
- 7 REIMBURSED IN ACCORDANCE WITH DEPARTMENT OF MANAGEMENT AND BUDGET
- 8 TRAVEL REIMBURSEMENT GUIDELINES FOR MILEAGE EXPENSES INCURRED IN
- 9 THE PERFORMANCE OF THEIR OFFICIAL DUTIES AS MEMBERS OF THE TASK
- 10 FORCE.
- 11 (12) THE DEPARTMENT AND THE MICHIGAN STRATEGIC FUND SHALL
- 12 PROVIDE STAFFING AND OTHER RESOURCES FOR THE SCHOOL CALENDAR TASK
- 13 FORCE AS REASONABLY REQUESTED BY THE TASK FORCE.
