THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1180. (1) A SCHOOL-AGE CHILD WHO IS ENROLLED IN A NON-
- 2 PUBLIC SCHOOL OR WHO IS BEING HOME SCHOOLED MAY PARTICIPATE IN
- 3 ANY EXTRACURRICULAR ACTIVITY OFFERED BY A SCHOOL OF THE SCHOOL
- 4 DISTRICT IN WHICH THE CHILD RESIDES. THE SCHOOL OFFICIALS OF THE
- 5 SCHOOL DISTRICT IN WHICH THE CHILD RESIDES SHALL ALLOW THE CHILD
- 6 TO PARTICIPATE IN THE EXTRACURRICULAR ACTIVITY ON THE SAME BASIS
- 7 AS PUPILS OF THE SCHOOL AT WHICH THE ACTIVITY IS OFFERED. THE
- 8 SCHOOL OFFICIALS OF THE SCHOOL DISTRICT SHALL NOT PROHIBIT OR
- 9 INTERFERE WITH THE CHILD'S PARTICIPATION IN THE EXTRACURRICULAR

- 5 THAT IS NOT PART OF THE SCHOOL DISTRICT'S ACADEMIC CURRICULUM BUT
