THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 811a. (1) A motorcycle safety course required under
- 2 section 312b conducted by a college or university, an intermedi-
- 3 ate school district, a local school district, a law enforcement
- 4 agency, or any other governmental agency located in this state
- 5 shall be conducted under this section.
- **6** (2) Except for motorcycle safety courses conducted under
- 7 section 811b, an applicant for a motorcycle safety course shall
- 8 pay not more than a \$25.00 course fee. The course fees shall be
- 9 used only for funding the administration and implementation of
- 10 the motorcycle safety education program.

- 1 (3) The state board of education is responsible for the
