- 4 for eligible teaching and administrative personnel.
- 5 (b) "Retirement system" means the Michigan public school
- 6 employees' retirement system created by the public school employ-
- 7 ees retirement act of 1979, Act No. 300 of the Public Acts of
- 8 1980, being sections 38.1301 to 38.1408 of the Michigan Compiled
- 9 Laws 1980 PA 300, MCL 38.1301 TO 38.1408.

- 1 (c) "Eligible employees" means the members of the faculty
