- 8 (ii) A POLITICAL PARTY COMMITTEE AS THAT TERM IS DEFINED IN
- 9 SECTION 11 OF THE MICHIGAN CAMPAIGN FINANCE ACT, 1976 PA 388, MCL
- **10** 169.211.
- 11 (iii) AN INDEPENDENT COMMITTEE AS THAT TERM IS DEFINED IN
- 12 SECTION 8 OF THE MICHIGAN CAMPAIGN FINANCE ACT, 1976 PA 388, MCL
- **13** 169.208.
- (iv) A COMMITTEE ORGANIZED BY A LEGISLATIVE CAUCUS OF A
- 15 CHAMBER OF THE LEGISLATURE.
- 16 (D) "OFFICER" MEANS EITHER OF THE FOLLOWING:
- (i) AN INDIVIDUAL LISTED AS AN OFFICER OF A CORPORATION, 17
- 18 LIMITED LIABILITY COMPANY, OR LIMITED LIABILITY PARTNERSHIP.
- 19 (ii) AN INDIVIDUAL WHO IS A SUCCESSOR TO AN INDIVIDUAL
- 20 DESCRIBED IN SUBPARAGRAPH (i).
