SENATE BILL NO. 502

(As passed the Senate October 4, 2001)

A bill to amend 1945 PA 327, entitled "Aeronautics code of the state of Michigan," (MCL 259.1 to 259.208) by adding section 80f.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 80F. (1) AN INDIVIDUAL SHALL NOT POSSESS, CARRY, OR
- 2 ATTEMPT TO POSSESS OR CARRY ANY OF THE FOLLOWING IN A STERILE
- 3 AREA OF A COMMERCIAL AIRPORT:
- 4 (A) FIREARM.
- 5 (B) EXPLOSIVE.
- 6 (C) KNIFE WITH A BLADE OF ANY LENGTH.
- 7 (D) RAZOR, BOX CUTTER, OR ITEM WITH A SIMILAR BLADE.
- 8 (E) DANGEROUS WEAPON.
- 9 (2) EXCEPT AS PROVIDED IN SUBSECTION (3), AN INDIVIDUAL WHO
- 10 VIOLATES SUBSECTION (1) IS GUILTY OF A MISDEMEANOR PUNISHABLE BY

- 16 (A) "COMMERCIAL AIRPORT" MEANS AN AIRPORT THAT HAS REGULARLY
- 17 SCHEDULED COMMERCIAL FLIGHTS TO AND FROM OTHER DESTINATIONS.
- 18 (B) "FELONY" MEANS THAT TERM AS DEFINED IN SECTION 1 OF
- 19 CHAPTER I OF THE CODE OF CRIMINAL PROCEDURE, 1927 PA 175,
- 20 MCL 761.1, OR A VIOLATION OF A LAW OF THE UNITED STATES THAT IS
- 21 DESIGNATED AS A FELONY OR THAT IS PUNISHABLE BY DEATH OR BY
- 22 IMPRISONMENT FOR MORE THAN 1 YEAR.
