- 4 TORY TO THE SUPERINTENDENT OF PUBLIC INSTRUCTION THAT THE PERSON
- 5 MEETS 1 OF THE FOLLOWING:
- 6 (A) HAS SUCCESSFULLY COMPLETED A COURSE APPROVED BY THE
- 7 DEPARTMENT IN CARDIOPULMONARY RESUSCITATION, INCLUDING A TEST
- 8 DEMONSTRATION ON A MANNEQUIN, AND HAS SUCCESSFULLY COMPLETED
- 9 INSTRUCTION APPROVED BY THE DEPARTMENT IN FOREIGN BODY AIRWAY
- 10 OBSTRUCTION MANAGEMENT, AND HOLDS VALID CERTIFICATION IN THESE
- 11 TOPICS ISSUED BY THE AMERICAN RED CROSS, AMERICAN HEART
