THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 42. (1) In the year in which presidential electors are
- 2 to be elected under section 43, each political party in this
- 3 state shall choose at its fall state convention a number of can-
- 4 didates for electors of president and vice-president of the
- 5 United States equal to the number of senators and representatives
- 6 in congress that this state is entitled to elect. ONE PRESIDEN-
- 7 TIAL ELECTOR SHALL BE CHOSEN FROM EACH CONGRESSIONAL DISTRICT,
- 8 AND 2 PRESIDENTIAL ELECTORS SHALL BE CHOSEN AT LARGE. The chair-
- 9 person and the secretary of the state central committee of each
- 10 political party shall, within 1 business day after the conclusion
- 11 of the state convention, forward by registered or certified mail
