- 1 SEC. 13E. (1) AS USED IN THIS SECTION:
- 2 (A) "EDUCATIONAL FACILITY" MEANS A BUILDING OWNED, LEASED,
- 3 OR UNDER THE CONTROL OF A PUBLIC OR NONPUBLIC SCHOOL OR SCHOOL
- 4 SYSTEM CONTAINING ANY OF GRADES K THROUGH 12.
- 5 (B) "FIBERGLASS" MEANS GLASS IN FIBROUS FORM USED FOR
- 6 INSULATION.
- 7 (C) "FOOD SERVICE ESTABLISHMENT" MEANS A RESTAURANT, COFFEE
- 8 SHOP, CAFETERIA, CAFE, GRILL, TAVERN, BAR, LOUNGE, NIGHTCLUB,
- 9 RENTAL HALL, CATERING KITCHEN, DELICATESSEN, THEATER, COMMISSARY,
- 10 OR ANY OTHER PLACE IN WHICH FOOD OR DRINK IS PREPARED FOR DIRECT
 - 11 CONSUMPTION THROUGH SERVICE ON THE PREMISES OR ELSEWHERE.
