- 4 (A) SELL, OFFER FOR SALE, OR OTHERWISE OFFER OR PROVIDE SOFT
- 5 DRINKS TO PUPILS AT SCHOOL AT ANY TIME.
- 6 (B) MAINTAIN, OR ALLOW TO BE MAINTAINED, A VENDING MACHINE
- 7 THAT IS LOCATED AT A SCHOOL OR ON SCHOOL GROUNDS, THAT SELLS SOFT
- 8 DRINKS, AND THAT IS ACCESSIBLE TO PUPILS.
- 9 (2) THIS SECTION DOES NOT PROHIBIT ANY OF THE FOLLOWING:
