THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 217I. (1) THE SECRETARY OF STATE SHALL DEVELOP AND
 ISSUE AN "AMERICAN NATIONAL RED CROSS" FUND-RAISING PLATE. THE
 SECRETARY OF STATE SHALL DESIGN THE PLATE, HAVING THE WORDS "RED
 CROSS" AND THE LOGO OF THE AMERICAN NATIONAL RED CROSS INSCRIBED
 ON THE PLATE. THE WORD "MICHIGAN" SHALL APPEAR ON THE PLATE.

6 (2) THE OWNER OF A VEHICLE REQUIRED TO BE REGISTERED UNDER
7 THIS ACT MAY APPLY, ON A FORM PRESCRIBED BY THE SECRETARY OF
8 STATE, FOR AN AMERICAN NATIONAL RED CROSS REGISTRATION PLATE

11 SHALL CREDIT TO THE FUND INTEREST AND EARNINGS FROM FUND
12 INVESTMENTS.

13 (3) MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR SHALL14 REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.

15 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE FUND ON16 A QUARTERLY BASIS TO THE AMERICAN NATIONAL RED CROSS.

17 (5) AS USED IN THIS SECTION, "FUND" MEANS THE FUND CREATED18 IN SUBSECTION (1).

19 (6) THE AMERICAN NATIONAL RED CROSS SHALL PROVIDE AN ANNUAL
20 ACCOUNTING OF THE MONEY RECEIVED UNDER THIS SECTION TO THE STATE
21 TREASURER.
