A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 803r.

- 1 SEC. 803R. (1) THE SECRETARY OF STATE SHALL DESIGN A SPE-
- 2 CIAL REGISTRATION PLATE THAT IS RED IN COLOR WITH CONTRASTING
- 3 NUMBERS AND LETTERS WITH AN INSCRIPTION THAT SAYS "FIREFIGHTER"
- 4 AND A PLATE THAT IS RED IN COLOR WITH CONTRASTING NUMBERS AND
- 5 LETTERS WITH AN INSCRIPTION THAT SAYS "EMT". THE WORD "MICHIGAN"
- 6 SHALL APPEAR ON THE SPECIAL REGISTRATION PLATE.
- 7 (2) AN INDIVIDUAL WHO IS A FIREFIGHTER AND AN INDIVIDUAL WHO
- 8 IS A CERTIFIED EMERGENCY MEDICAL TECHNICIAN MAY APPLY TO THE SEC-
- 9 RETARY OF STATE FOR THE APPROPRIATE SPECIAL REGISTRATION PLATE
- 10 DEVELOPED UNDER THIS SECTION.

- 1 (3) APPLICATION FOR A SPECIAL REGISTRATION PLATE UNDER THIS

- 10 (5) A RENEWAL TAB SHALL BE ISSUED UPON PAYMENT OF THE REGU-
- 11 LAR REGISTRATION TAX AND SUFFICIENT PROOF THAT THE INDIVIDUAL IS
- 12 STILL A FIREFIGHTER OR A CERTIFIED EMERGENCY MEDICAL TECHNICIAN.
- 13 A SERVICE FEE SHALL NOT BE COLLECTED FOR A RENEWAL TAB.
