## **SENATE BILL No. 723**

October 17, 2001, Introduced by Senators JOHNSON, BULLARD, GARCIA, MC COTTER, HAMMERSTROM and GOSCHKA and referred to the Committee on Families, Mental Health and Human Services.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending sections 81 and 81a (MCL 750.81 and 750.81a), section 81 as amended by 2000 PA 462 and section 81a as amended by 1999 PA 270.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 81. (1) A person who assaults or assaults and batters
