## HOUSE BILL No. 4402

## March 18, 2003, Introduced by Rep. Shulman and referred to the Committee on Appropriations.

A bill to amend 1979 PA 94, entitled "The state school aid act of 1979," by amending section 11 (MCL 388.1611), as amended by 2002 PA 521.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 11. (1) For the fiscal year ending September 30, 2 2002, there is appropriated for the public schools of this state 3 and certain other state purposes relating to education the sum of 4 \$10,990,148,200.00 from the state school aid fund established by 5 section 11 of article IX of the state constitution of 1963 and the sum of \$198,413,500.00 from the general fund. For the fiscal 6 7 year ending September 30, 2003, there is appropriated for the 8 public schools of this state and certain other state purposes 9 relating to education the sum of  $\frac{11,259,441,400.00}{11,259,441,400.00}$ 10 \$ \_\_\_\_\_ from the state school aid fund established by

1 section 11 of article IX of the state constitution of 1963, the sum of \$198,413,500.00 from the general fund, and the sum of 2 \$700,000.00 from local revenues. However, if legislation 3 authorizing the transfer of \$79,500,000.00 from the Michigan 4 5 employment security act contingent fund, penalties and interest subaccount, is not enacted and in effect on or before October 1, 6 2002, there is instead appropriated from the general fund for 7 2002-2003 the sum of \$122,656,500.00. For the fiscal year ending 8 September 30, 2004, there is appropriated for the public schools 9 10 of this state and certain other state purposes relating to education the sum of <u>\$11,246,667,400.00</u> **\$** from 11 12 the state school aid fund established by section 11 of article IX of the state constitution of 1963 and the sum of \$198,413,500.00 13 from the general fund. In addition, available federal funds are 14 appropriated for each of those fiscal years. 15

16 (2) The appropriations under this section shall be allocated as provided in this act. Money appropriated under this section 17 18 from the general fund and from available federal funds shall be expended to fund the purposes of this act before the expenditure 19 20 of money appropriated under this section from the state school aid fund. If the maximum amount appropriated under this section 21 from the state school aid fund for a fiscal year exceeds the 22 amount necessary to fully fund allocations under this act from 23 the state school aid fund, that excess amount shall not be 24 expended in that state fiscal year and shall not lapse to the 25 general fund, but instead shall remain in the state school aid 26 27 fund.

1 (3) If the maximum amount appropriated under this section and section 11f from the state school aid fund for a fiscal year 2 exceeds the amount available for expenditure from the state 3 school aid fund for that fiscal year, payments under sections 4 5 11f, 11g, 22a, 31d, 51a(2), and 51c shall be made in full. In addition, for districts beginning operations after 1994-95 that 6 qualify for payments under section 22b, payments under 7 section 22b shall be made so that the qualifying districts 8 receive an amount equal to the 1994-95 foundation allowance of 9 the district in which the district beginning operations after 10 The amount of the payment to be made under 11 1994-95 is located. 12 section 22b for these qualifying districts shall be as calculated 13 under section 22a, with the balance of the payment under section 22b being subject to the proration otherwise provided 14 under this subsection. State payments under each of the other 15 sections of this act from all state funding sources shall be 16 17 prorated on an equal percentage basis as necessary to reflect the amount available for expenditure from the state school aid fund 18 for that fiscal year. However, if the department of treasury 19 20 determines that proration will be required under this subsection, the department of treasury shall notify the state budget 21 22 director, and the state budget director shall notify the legislature at least 30 calendar days or 6 legislative session 23 days, whichever is more, before the department reduces any 24 payments under this act because of the proration. During the 30 25 calendar day or 6 legislative session day period after that 26 27 notification by the state budget director, the department shall

1 not reduce any payments under this act because of proration under 2 this subsection. The legislature may prevent proration from 3 occurring by, within the 30 calendar day or 6 legislative session 4 day period after that notification by the state budget director, 5 enacting legislation appropriating additional funds from the 6 general fund, countercyclical budget and economic stabilization 7 fund, state school aid fund balance, or another source to fund 8 the amount of the projected shortfall.

9 (4) Except for the allocation under section 26a, any general
10 fund allocations under this act that are not expended by the end
11 of the state fiscal year are transferred to the state school aid
12 fund.
