SENATE BILL No. 600

June 25, 2003, Introduced by Senators BASHAM, BISHOP and ALLEN and referred to the Committee on Judiciary.

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms and gas ejecting devices; to prohibit the buying, selling, or carrying of certain firearms and gas ejecting devices without a license or other authorization; to provide for the forfeiture of firearms under certain circumstances; to provide for penalties and remedies; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; to prohibit certain conduct against individuals who apply for or receive a license to carry a concealed pistol; to make appropriations; to prescribe certain conditions for the appropriations; and to repeal all acts and parts of acts inconsistent with this act,"

by amending section 12a (MCL 28.432a), as amended by 2002 PA 719.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- . Sec. 12a. The requirements of this act for obtaining a

 - (a) A peace officer of a duly authorized police agency of the

- 25 assembly or practice or while carrying a concealed pistol for
- 26 purposes of that military organization.
- 27 (f) A resident of another state who is licensed by that state

- 1 to carry a concealed pistol.
- 2 (g) The regular and ordinary transportation of a pistol as
- 3 merchandise by an authorized agent of a person licensed to
- 4 manufacture firearms.
- 5 (h) A person while carrying a pistol unloaded in a wrapper or
- 6 container in the trunk of his or her vehicle or, if the vehicle
- 7 does not have a trunk, from transporting that pistol unloaded in
- 8 a locked compartment or container that is separated from the
- 9 ammunition for that pistol from the place of purchase to his or
- 10 her home or place of business or to a place of repair or back to
- 11 his or her home or place of business, or in moving goods from 1
- 12 place of abode or business to another place of abode or
- 13 business.
- (i) A peace officer or law enforcement officer from Canada.
