HOUSE SUBSTITUTE FOR SENATE BILL NO. 226

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding part 23.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 PART 23. AGRICULTURE AND THE ENVIRONMENT
- 2 SEC. 2301. AS USED IN THIS PART:
- 3 (A) "DEPARTMENT" MEANS THE DEPARTMENT OF ENVIRONMENTAL
- 4 QUALITY.
- 5 (B) "DIRECTOR" MEANS THE DIRECTOR OF THE DEPARTMENT.
- 6 (C) "ROUNDTABLE" MEANS THE AGRICULTURE AND RURAL COMMUNITIES
- 7 ROUNDTABLE CONVENED UNDER SECTION 2303.
- 8 (D) "RURAL COUNTY" MEANS A COUNTY WITH A POPULATION OF LESS
- 9 THAN 70,000.

- 1 (E) "STANDING COMMITTEES" MEANS THE COMMITTEES OF THE SENATE
- 2 AND HOUSE OF REPRESENTATIVES WITH PRIMARY RESPONSIBILITY FOR
- 3 AGRICULTURE.
- 4 SEC. 2303. (1) THE DIRECTOR SHALL CONVENE AN AGRICULTURE AND
- 5 RURAL COMMUNITIES ROUNDTABLE TO DISCUSS HOW THE LAWS, RULES AND
- 6 POLICIES ADMINISTERED BY THE DEPARTMENT AFFECT FARMERS, FOOD
- 7 PROCESSORS, AGRIBUSINESS, RURAL COUNTIES, AND CITIES, VILLAGES, AND
- 8 TOWNSHIPS IN RURAL COUNTIES.
- 9 (2) THE DIRECTOR SHALL INVITE AT LEAST ALL OF THE FOLLOWING TO
- 10 PARTICIPATE IN THE ROUNDTABLE:
- 11 (A) TWO INDIVIDUALS FROM AN ASSOCIATION REPRESENTING FARMERS.
- 12 (B) TWO INDIVIDUALS FROM AN ASSOCIATION REPRESENTING FOOD
- 13 PROCESSORS.
- 14 (C) TWO INDIVIDUALS FROM AN ASSOCIATION REPRESENTING
- 15 AGRIBUSINESS.
- 16 (D) ONE INDIVIDUAL REPRESENTING A TOWNSHIP IN A RURAL COUNTY.
- 17 (E) ONE INDIVIDUAL REPRESENTING A CITY OR VILLAGE IN A RURAL
- 18 COUNTY.
- 19 (F) ONE INDIVIDUAL REPRESENTING A RURAL COUNTY.
- 20 (3) BEFORE EXTENDING INVITATIONS TO PARTICIPATE IN THE
- 21 ROUNDTABLE, THE DIRECTOR SHALL CONSULT WITH THE CHAIRPERSONS OF
- 22 STANDING COMMITTEES.
- 23 SEC. 2305. (1) THE FIRST MEETING OF THE ROUNDTABLE SHALL BE
- 24 CONVENED BY THE DIRECTOR WITHIN 90 DAYS AFTER THE EFFECTIVE DATE OF
- 25 THE AMENDATORY ACT THAT ADDED THIS SECTION.
- 26 (2) THE DIRECTOR SHALL CONVENE THE ROUNDTABLE AT LEAST TWICE
- 27 EACH CALENDAR YEAR, EXCEPT THAT IF THE AMENDATORY ACT THAT ADDED

- THIS SECTION TAKES EFFECT AFTER SEPTEMBER 30, THE ROUNDTABLE SHALL 1
- 2 CONVENE AT LEAST ONCE THE FIRST CALENDAR YEAR. THE ROUNDTABLE MAY
- 3 ADVISE THE DIRECTOR ON THE NEED FOR A MORE FREQUENT MEETING
- 4 SCHEDULE.
- (3) THE MEETINGS OF THE ROUNDTABLE SHALL BE OPEN TO THE 5
- GENERAL PUBLIC AND SHALL BE HELD IN A PLACE AVAILABLE TO THE
- 7 GENERAL PUBLIC.
- (4) THE DEPARTMENT SHALL PROVIDE NOTICE OF EACH MEETING OF THE 8
- ROUNDTABLE BY POSTING ON THE DEPARTMENT WEBSITE AND SUCH OTHER
- 10 MEANS AS THE DEPARTMENT DETERMINES APPROPRIATE.
- 11 (5) AT LEAST 1 MEETING OF THE ROUNDTABLE EACH YEAR SHALL BE
- 12 HELD IN A RURAL COMMUNITY. AT SUCH A MEETING, THE PUBLIC SHALL BE
- 13 PROVIDED AN OPPORTUNITY TO ADDRESS THE ROUNDTABLE ON ISSUES WITHIN
- 14 ITS PURVIEW.
- (6) THE DEPARTMENT SHALL PREPARE A SUMMARY OF EACH MEETING OF 15
- THE ROUNDTABLE INCLUDING A DEPARTMENT RESPONSE TO ISSUES RAISED 16
- DURING THE ROUNDTABLE MEETING. THE DEPARTMENT SHALL DO BOTH OF THE 17
- 18 FOLLOWING:
- 19 (A) POST THE SUMMARY ON ITS WEBSITE.
- 20 (B) PROVIDE A COPY OF THE SUMMARY TO THE MEMBERS OF THE
- 21 ROUNDTABLE, ANY MEMBER OF THE PUBLIC REQUESTING A COPY, AND TO THE
- 22 STANDING COMMITTEES.
