SUBSTITUTE FOR HOUSE BILL NO. 5653

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 16337, 17001, 17008, 17025, 17066, 17074, 17078, 17501, 17508, 18001, 18011, and 18021 (MCL 333.16337, 333.17001, 333.17008, 333.17025, 333.17066, 333.17074, 333.17078, 333.17501, 333.17508, 333.18001, 333.18011, and 333.18021), section 16337 as added by 1993 PA 79, sections 17001 and 17501 as amended by 2005 PA 264, section 17025 as amended by 1980 PA 146, sections 17066, 17074, and 17078 as amended by 1990 PA 247, and section 18021 as amended by 1993 PA 79, and by adding sections 18008, 18048, 18049, 18050, 18054, 18056, and 18058; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 16337. Fees for a person licensed or seeking licensure to

- 2 170, -or part 175, **OR PART 180** are as follows:
- 3 (a) Application processing fee \$ 30.00
- 4 (b) License fee, per year 50.00
- 6 (d) Limited license, per year 25.00
- 7 Sec. 17001. (1) As used in this part:
- 8 (a) "Academic institution" means either of the following:
- **9** (i) A medical school approved by the board.
- 10 (ii) A hospital licensed under article 17 that meets all of the
- 11 following requirements:
- 12 (A) Was the sole sponsor or a co-sponsor, if each other co-
- 13 sponsor is either a medical school approved by the board or a
- 14 hospital owned by the federal government and directly operated by
- 15 the United States department of veterans' affairs, of not less than
- 16 4 postgraduate education residency programs approved by the board
- 17 under section 17031(1) for not less than the 3 years immediately

- 25 offering, undertaking, attempting to do, or holding oneself out as

- 17 Sec. 17008. Practice as a physician's assistant is a health
- 18 profession subfield of the practice of medicine, -and- osteopathic
- 19 medicine and surgery, AND PODIATRIC MEDICINE AND SURGERY.
- Sec. 17025. (1) A joint task force is created for the health
- 21 profession subfields licensed under this part. and part 175. The
- 22 task force shall consist of the following -9 10 members, who shall
- 23 meet the requirements of part 161: 1 member each from the board of
- 24 medicine, -and the board of osteopathic medicine and surgery, AND
- 25 THE BOARD OF PODIATRIC MEDICINE AND SURGERY holding a license other

- 25 Sec. 17508. Practice as a physician's assistant is a health
- 26 profession subfield of the practice of osteopathic medicine and
- 27 surgery, —and— the practice of medicine, AND THE PRACTICE OF

- 1 PODIATRIC MEDICINE AND SURGERY.
- 2 Sec. 18001. (1) As used in this part:
- 3 (a) "Podiatrist" means a physician and surgeon licensed under
- 4 this article to engage in the practice of podiatric medicine and
- 5 surgery.
- 6 (B) "PRACTICE AS A PHYSICIAN'S ASSISTANT" MEANS THE PRACTICE
- 7 OF MEDICINE, OSTEOPATHIC MEDICINE AND SURGERY, AND PODIATRIC
- 8 MEDICINE AND SURGERY UNDER THE SUPERVISION OF A PHYSICIAN OR

- 2 SEC. 18008. PRACTICE AS A PHYSICIAN'S ASSISTANT IS A HEALTH
- 3 PROFESSION SUBFIELD OF THE PRACTICE OF PODIATRIC MEDICINE AND
- 4 SURGERY, THE PRACTICE OF OSTEOPATHIC MEDICINE AND SURGERY, AND THE
- 5 PRACTICE OF MEDICINE.
- 6 Sec. 18011. A person shall not engage in the practice of
- 7 podiatric medicine and surgery OR PRACTICE AS A PHYSICIAN'S
- 8 ASSISTANT unless licensed or otherwise authorized by this article.
- 9 Sec. 18021. (1) The Michigan board of podiatric medicine and
- 10 surgery is created in the department and shall consist of the
- 11 following 9 voting members who shall meet the requirements of part
- 12 161: 5 podiatrists, 1 PHYSICIAN'S ASSISTANT, and -4- 3 public
- 13 members.
- 14 (2) THE BOARD OF PODIATRIC MEDICINE AND SURGERY DOES NOT HAVE

- 27 UNDER ARTICLE 17 MAY SUPERVISE MORE THAN 4 PHYSICIAN'S ASSISTANTS

- 1 AT THE HEALTH FACILITY OR AGENCY.
- 2 (3) THE DEPARTMENT MAY PROMULGATE RULES FOR THE APPROPRIATE
- 3 DELEGATION AND UTILIZATION OF A PHYSICIAN'S ASSISTANT BY A
- 4 PODIATRIST, INCLUDING, BUT NOT LIMITED TO, RULES TO PROHIBIT OR
- 5 OTHERWISE RESTRICT THE DELEGATION OF CERTAIN PODIATRIC SERVICES OR
- 6 REQUIRE HIGHER LEVELS OF SUPERVISION IF THE BOARD DETERMINES THAT
- 7 SUCH SERVICES REQUIRE EXTENSIVE TRAINING, EDUCATION, OR ABILITY OR
- 8 POSE SERIOUS RISKS TO THE HEALTH OR SAFETY OF PATIENTS.
- 9 SEC. 18049. (1) IN ADDITION TO THE OTHER REQUIREMENTS OF THIS
- 10 SECTION AND SUBJECT TO SUBSECTION (5), A PODIATRIST WHO SUPERVISES
- 11 A PHYSICIAN'S ASSISTANT IS RESPONSIBLE FOR ALL OF THE FOLLOWING:
- 12 (A) VERIFICATION OF THE PHYSICIAN'S ASSISTANT'S CREDENTIALS.
- 13 (B) EVALUATION OF THE PHYSICIAN'S ASSISTANT'S PERFORMANCE.
- 14 (C) MONITORING THE PHYSICIAN'S ASSISTANT'S PRACTICE AND
- 15 PROVISION OF PODIATRIC SERVICES.
- 16 (2) SUBJECT TO SECTION 18048, A PODIATRIST WHO SUPERVISES A

- 18 ASSISTANT THE PERFORMANCE OF PODIATRIC SERVICES FOR A PATIENT WHO
- 19 IS UNDER THE CASE MANAGEMENT RESPONSIBILITY OF THE PODIATRIST, IF
- 20 THE DELEGATION IS CONSISTENT WITH THE PHYSICIAN'S ASSISTANT'S
- 21 TRAINING. A PODIATRIST SHALL ONLY SUPERVISE A PHYSICIAN'S ASSISTANT
- 22 IN THE PERFORMANCE OF THOSE DUTIES INCLUDED WITHIN HIS OR HER SCOPE
- 23 OF PRACTICE.
- 24 (3) A PODIATRIST WHO SUPERVISES A PHYSICIAN'S ASSISTANT IS
- 25 RESPONSIBLE FOR THE CLINICAL SUPERVISION OF EACH PHYSICIAN'S
- 26 ASSISTANT TO WHOM THE PHYSICIAN DELEGATES THE PERFORMANCE OF
- 27 PODIATRIC SERVICES UNDER SUBSECTION (2).

- 1 (4) SUBJECT TO SUBSECTION (5), A PODIATRIST WHO SUPERVISES A
- 2 PHYSICIAN'S ASSISTANT SHALL KEEP ON FILE IN THE PHYSICIAN'S OFFICE
- 3 OR IN THE HEALTH FACILITY OR AGENCY IN WHICH THE PODIATRIST
- 4 SUPERVISES THE PHYSICIAN'S ASSISTANT A PERMANENT, WRITTEN RECORD
- 5 THAT INCLUDES THE PODIATRIST'S NAME AND LICENSE NUMBER AND THE NAME
- 6 AND LICENSE NUMBER OF EACH PHYSICIAN'S ASSISTANT SUPERVISED BY THE
- 7 PODIATRIST.
- 8 (5) A GROUP OF PODIATRISTS PRACTICING OTHER THAN AS SOLE
- 9 PRACTITIONERS MAY DESIGNATE 1 OR MORE PODIATRISTS IN THE GROUP TO
- 10 FULFILL THE REQUIREMENTS OF SUBSECTIONS (1) AND (4).
- 11 SEC. 18050. IN ADDITION TO ITS OTHER POWERS AND DUTIES UNDER
- 12 THIS ARTICLE, THE BOARD MAY PROHIBIT A PODIATRIST FROM SUPERVISING
- 13 1 OR MORE PHYSICIAN'S ASSISTANTS FOR ANY OF THE GROUNDS SET FORTH
- 14 IN SECTION 16221 OR FOR FAILURE TO SUPERVISE A PHYSICIAN'S
- 15 ASSISTANT IN ACCORDANCE WITH THIS PART AND RULES PROMULGATED UNDER
- 16 THIS PART.
- 17 SEC. 18054. THE BOARD SHALL MAKE WRITTEN RECOMMENDATIONS ON
- 18 CRITERIA FOR THE APPROVAL OF PHYSICIAN'S ASSISTANTS AND ON CRITERIA
- 19 FOR THE VALUATION OF PHYSICIAN'S ASSISTANTS TRAINING PROGRAMS TO
- 20 THE TASK FORCE ON PHYSICIAN'S ASSISTANTS.
- 21 SEC. 18056. THIS PART DOES NOT APPLY TO A STUDENT IN TRAINING
- 22 TO BECOME A PHYSICIAN'S ASSISTANT WHILE PERFORMING DUTIES ASSIGNED
- 23 AS PART OF THE TRAINING.
- 24 SEC. 18058. THIS PART DOES NOT REQUIRE NEW OR ADDITIONAL THIRD
- 25 PARTY REIMBURSEMENT OR MANDATED WORKER'S COMPENSATION BENEFITS FOR
- 26 SERVICES RENDERED BY AN INDIVIDUAL AUTHORIZED TO PRACTICE AS A
- 27 PHYSICIAN'S ASSISTANT UNDER THIS PART.

- Enacting section 1. Section 17525 of the public health code, 1
- 1978 PA 368, MCL 333.17525, is repealed. 2
- Enacting section 2. This amendatory act takes effect 6 months 3
- after it is enacted into law.
