## HOUSE SUBSTITUTE FOR SENATE BILL NO. 934

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 307b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 307B. (1) BEGINNING OCTOBER 1, 2010, WHEN ANY MALE
- 2 CITIZEN OF THE UNITED STATES OR A MALE IMMIGRANT TO THE UNITED
- 3 STATES WHO IS LESS THAN 26 YEARS OF AGE APPLIES FOR AN OPERATOR'S
- 4 LICENSE OR CHAUFFEUR'S LICENSE, THE SECRETARY OF STATE SHALL, WITH
- 5 THE APPLICANT'S CONSENT, OBTAIN THE INFORMATION THAT IS NECESSARY
- 6 TO REGISTER THE APPLICANT WITH THE FEDERAL SELECTIVE SERVICE SYSTEM
- 7 IN COMPLIANCE WITH THE REQUIREMENTS OF 50 USC APPX 453, INCLUDING,
- 8 BUT NOT LIMITED TO, THE APPLICANT'S SOCIAL SECURITY NUMBER.
- 9 (2) EACH APPLICATION DESCRIBED IN SUBSECTION (1) SHALL
- 10 CONTAIN ALL OF THE FOLLOWING:

- 1 (A) A STATEMENT THAT, IF THE APPLICANT GIVES HIS CONSENT TO
- 2 THE SECRETARY OF STATE TO PROVIDE HIS REGISTRATION INFORMATION TO
- 3 THE SELECTIVE SERVICE SYSTEM, THE SECRETARY OF STATE IS AUTHORIZED
- 4 TO PROVIDE THAT INFORMATION TO THE SELECTIVE SERVICE SYSTEM UNDER
- 5 THIS SECTION.
- 6 (B) THE FOLLOWING STATEMENT: "IF I AM LESS THAN 18 YEARS OF
- 7 AGE AND GIVE MY CONSENT TO THE SECRETARY OF STATE TO PROVIDE THE
- 8 INFORMATION NECESSARY TO REGISTER ME FOR SELECTIVE SERVICE, I
- 9 UNDERSTAND THAT I WILL AUTOMATICALLY BE REGISTERED FOR SELECTIVE
- 10 SERVICE WHEN I BECOME 18 YEARS OF AGE IF REQUIRED BY FEDERAL LAW.".
- 11 (C) A STATEMENT OF THE CRIMINAL PENALTIES AND OTHER SANCTIONS
- 12 THAT APPLY FOR FAILING TO REGISTER WITH SELECTIVE SERVICE.
- 13 (D) THE FOLLOWING STATEMENT: "I ACKNOWLEDGE HAVING BEEN GIVEN
- 14 INFORMATION REGARDING THE PENALTIES FOR NOT REGISTERING FOR
- 15 SELECTIVE SERVICE.".
- 16 (E) A STATEMENT APPEARING IN CAPITALIZED, BOLD-FACED TYPE THAT
- 17 DECLINING TO GIVE CONSENT TO REGISTRATION UNDER THIS SECTION DOES
- 18 NOT AFFECT THE APPLICANT'S PRIVILEGE TO RECEIVE AN OPERATOR'S OR
- 19 CHAUFFEUR'S LICENSE.
- 20 (F) A LOCATION ON THE APPLICATION WHERE THE APPLICANT SHALL
- 21 INDICATE THAT HE EITHER CONSENTS TO FORWARDING HIS REGISTRATION
- 22 INFORMATION TO THE SELECTIVE SERVICE SYSTEM OR THAT HE DOES NOT
- 23 CONSENT TO FORWARDING HIS REGISTRATION INFORMATION TO THE SELECTIVE
- 24 SERVICE SYSTEM.
- 25 (3) THE SECRETARY OF STATE SHALL FORWARD THE INFORMATION
- 26 OBTAINED UNDER SUBSECTION (1) TO THE FEDERAL SELECTIVE SERVICE
- 27 SYSTEM IN A FORMAT CONSISTENT WITH SELECTIVE SERVICE SYSTEM

- REQUIREMENTS. 1
- 2 (4) THE SECRETARY OF STATE SHALL NOT FORWARD ANY INFORMATION
- REGARDING AN APPLICANT WHO IS LESS THAN 18 YEARS OF AGE TO THE 3
- SELECTIVE SERVICE SYSTEM UNDER THIS SECTION UNLESS THE APPLICANT
- GIVES HIS CONSENT TO PROVIDE THAT INFORMATION TO THE SELECTIVE 5
- SERVICE SYSTEM AS PROVIDED IN THIS SECTION.
- Enacting section 1. This amendatory act takes effect October 7
