## **SENATE BILL No. 205**

February 16, 2005, Introduced by Senators HAMMERSTROM, PATTERSON, BERNERO, GEORGE, JACOBS and BARCIA and referred to the Committee on Health Policy.

A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1523.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 1523. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION, NOT LATER THAN JULY 1, 2007, THE BOARD OF A SCHOOL 2 DISTRICT OR LOCAL ACT SCHOOL DISTRICT OR BOARD OF DIRECTORS OF A 3 4 PUBLIC SCHOOL ACADEMY SHALL REQUIRE EACH PERSON IT EMPLOYS AS A COACH OF AN INTERSCHOLASTIC ATHLETIC ACTIVITY, OR ASSIGNS TO SERVE 5 6 AS A COACH OF AN INTERSCHOLASTIC ATHLETIC ACTIVITY, TO HOLD VALID 7 CERTIFICATION IN SPORT SAFETY TRAINING. CERTIFICATION IN SPORT 8 SAFETY TRAINING MAY BE ACHIEVED BY SUCCESSFUL COMPLETION OF A SPORT SAFETY TRAINING COURSE APPROVED BY THE STATE BOARD. THE SPORT
 SAFETY TRAINING COURSE SHALL INCLUDE INSTRUCTION IN AT LEAST
 CARDIOPULMANARY RESUSCITATION, EMERGENCY PROCEDURES, FIRST AID, AND
 INJURY PREVENTION. THIS REQUIREMENT DOES NOT APPLY TO ANY OF THE
 FOLLOWING:

6 (A) A PERSON WHO DEMONSTRATES THAT HE OR SHE HAS PHYSICAL
7 LIMITATIONS THAT MAKE IT IMPRACTICABLE FOR THE PERSON TO COMPLETE
8 THE COURSE AND OBTAIN THE REQUIRED CERTIFICATION UNDER THIS
9 SUBSECTION.

10(B) A PERSON WHO IS LICENSED UNDER PART 170, 172, 175, OR 20911OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.1101 TO 333.25211.

12 (2) A PERSON WHO HOLDS THE SPORT SAFETY CERTIFICATION DESCRIBED IN THIS SECTION AND WHO IN AN EMERGENCY PROVIDES PHYSICAL 13 AID WITHIN THE SCOPE OF THE SPORT SAFETY TRAINING TO ANOTHER PERSON 14 IN THE COURSE OF HIS OR HER EMPLOYMENT OR SERVICE AS AN 15 INTERSCHOLASTIC ATHLETIC COACH IS NOT LIABLE IN A CIVIL ACTION FOR 16 DAMAGES RESULTING FROM AN ACT OR OMISSION OCCURRING IN PROVIDING 17 THAT AID EXCEPT AN ACT OR OMISSION CONSTITUTING GROSS NEGLIGENCE OR 18 19 WILLFUL AND WANTON MISCONDUCT.

20 (3) THIS SECTION DOES NOT CREATE A DUTY TO ACT ON THE PART OF21 A PERSON WHO HOLDS SPORT SAFETY CERTIFICATION.

22 Enacting section 1. This amendatory act takes effect July 1,23 2005.
