SUBSTITUTE FOR SENATE BILL NO. 1093

A bill to make appropriations for the department of military and veterans affairs for the fiscal year ending September 30, 2007; to provide for the expenditure of the appropriations; to provide for certain powers and duties of the department of military and veterans affairs, other state agencies, and local units of government related to the appropriations; and to provide for the preparation of certain reports related to the appropriations.

13	Sec. 201. Pursuant to section 30 of article IX of the state
14	constitution of 1963, total state spending from state resources
15	under part 1 for fiscal year 2006-2007 is \$67,210,200.00 and state
16	spending from state resources to be paid to local units of
17	government for fiscal year 2006-2007 is \$120,000.00. The itemized

- 1 Sec. 202. The appropriations authorized under this act are
- 2 subject to the management and budget act, 1984 PA 431, MCL 18.1101
- 3 to 18.1594.
- 4 Sec. 203. As used in this act:
- 5 (a) "Department" means the department of military and veterans
- 6 affairs.
- 7 (b) "Director" means the director of the department of
- 8 military and veterans affairs.
- 9 (c) "DOD" means the United States department of defense.
- 10 (d) "DOD-DOA-NGB" means the DOD department of the army,
- 11 national guard bureau.
- 12 (e) "DVA" means the United States department of veterans'
- 13 affairs.
- 14 (f) "DVA-VHA" means the DVA veterans' health administration.
- 15 (g) "FTE" means full-time equated.
- 16 (h) "HHS" means the United States department of health and
- 17 human services.
- 18 (i) "IDG" means interdepartmental grant.
- 19 Sec. 204. The department of civil service shall bill the
- 20 departments and agencies at the end of the first fiscal quarter for
- 21 the 1% charge authorized by section 5 of article XI of the state
- 22 constitution of 1963. Payments shall be made for the total amount
- 23 of the billing by the end of the second fiscal quarter.
- Sec. 205. (1) Beginning October 1, a hiring freeze is imposed
- 25 on the state classified civil service. State departments and
- 26 agencies are prohibited from hiring any new full-time state
- 27 classified civil service employees and prohibited from filling any

- 1 vacant state classified civil service positions. This hiring freeze
- 2 does not apply to internal transfers of classified employees from 1
- 3 position to another within a department.
- 4 (2) The state budget director shall grant exceptions to this
- 5 hiring freeze when the state budget director believes that the
- 6 hiring freeze will result in rendering a state department or agency
- 7 unable to deliver basic services, cause loss of revenue to the
- 8 state, result in the inability of the state to receive federal
- 9 funds, or necessitate additional expenditures that exceed any
- 10 savings from maintaining a vacancy. The state budget director shall
- 11 report by the last business day of each month to the chairpersons
- 12 of the senate and house of representatives standing committees on
- 13 appropriations the number of exceptions to the hiring freeze
- 14 approved during the previous month and the justification for the
- 15 exception.
- 16 Sec. 207. Sixty days before beginning any effort to privatize,
- 17 the department shall submit a complete project plan to the
- 18 appropriate senate and house of representatives appropriations
- 19 subcommittees and the senate and house fiscal agencies. The plan
- 20 shall include the criteria under which the privatization initiative
- 21 will be evaluated. The evaluation shall be completed and submitted
- 22 to the appropriate senate and house of representatives
- 23 appropriations subcommittees and the senate and house fiscal
- 24 agencies within 30 months.
- Sec. 208. Unless otherwise specified, the department shall use
- 26 the Internet to fulfill the reporting requirements of this act.
- 27 This requirement may include transmission of reports via electronic

- 1 mail to the recipients identified for each reporting requirement or
- 2 it may include placement of reports on an Internet or Intranet
- 3 site.
- 4 Sec. 209. Funds appropriated in part 1 shall not be used for
- 5 the purchase of foreign goods or services, or both, if
- 6 competitively priced and of comparable quality American goods or
- 7 services, or both, are available. Preference should be given to
- 8 goods or services, or both, manufactured or provided by Michigan
- 9 businesses, if they are competitively priced and of comparable
- 10 quality.
- 11 Sec. 210. The director of each department receiving
- 12 appropriations in part 1 shall take all reasonable steps to ensure
- 13 businesses in deprived and depressed communities compete for and
- 14 perform contracts to provide services or supplies, or both. Each
- 15 director shall strongly encourage firms with which the department
- 16 contracts to subcontract with certified businesses in depressed and
- 17 deprived communities for services, supplies, or both.
- 18 Sec. 211. The departments and agencies receiving
- 19 appropriations in part 1 shall receive and retain copies of all
- 20 reports funded from appropriations in part 1. The department shall
- 21 follow all federal guidelines and state laws regarding short-term
- 22 and long-term retention of records.
- 23 Sec. 212. (1) Of the funds appropriated in part 1 for military
- 24 training sites and support facilities, there shall be established a
- 25 Michigan national guard education assistance program. Disbursements
- 26 to the educational assistance program shall not exceed
- 27 \$1,100,000.00 without legislative approval. Under the program, a

- 1 member of the national guard who is in active service and who
- 2 enrolls as a full- or part-time student at a public or private
- 3 state college or university may be eligible to receive up to an
- 4 equivalent of 50% of the total cost of tuition not to exceed
- 5 \$2,000.00, as education assistance, in any academic year.
- 6 (2) As used in this section, an eligible person means a member
- 7 of the Michigan national guard who is in active service, as defined
- 8 in section 105 of the Michigan military act, 1967 PA 150, MCL
- 9 32.505. An eligible person does not include a member of the
- 10 Michigan national guard or air national guard who is absent without
- 11 leave or who is under charges as described in the Michigan code of
- 12 military justice of 1980, 1980 PA 523, MCL 32.1001 to 32.1148.
- 13 (3) The department of military and veterans affairs, office of
- 14 the adjutant general shall administer the education assistance
- 15 program and prescribe forms and procedures to effectively carry out
- 16 the education assistance program.
- 17 (4) An eligible person shall apply to the department of
- 18 military and veterans affairs, office of the adjutant general for
- 19 education assistance and shall provide evidence of attendance and
- 20 completion of the course of study with a grade of at least 2.0 on a
- 21 4.0 scale, or its equivalent. The adjutant general shall approve
- 22 the application for reimbursement if the applicant meets the
- 23 definition of an eligible person under subsection (2) and other
- 24 criteria as established by the adjutant general.
- 25 (5) The education assistance program applies to any course of
- 26 instruction that is included in an associate, undergraduate, or
- 27 postgraduate degree program offered by a college or university of

- 1 this state.
- 2 (6) The education assistance program applies to an eligible
- 3 person notwithstanding any other educational incentive or benefit
- 4 received by the eligible person under any other educational
- 5 assistance program provided by any other state.
- 6 (7) An eligible person who successfully completes the course
- 7 of study with a grade of at least 2.0 on a 4.0 scale, or its
- 8 equivalent, shall be eligible for reimbursement.
- 9 (8) The department of military and veterans affairs may use
- 10 funds from the appropriated funds to administer the education
- 11 assistance program.
- 12 (9) Reimbursed members who do not complete their national
- 13 guard obligation shall pay the state for money received from the
- 14 state for tuition. Members who fail to repay the state within the
- 15 time limits established by the adjutant general shall be indebted
- 16 to the state. The department shall work in conjunction with the
- 17 department of treasury for inclusion in the tax intercept program
- 18 for amounts due the state.
- 19 (10) A portion of the funds for the Michigan national guard
- 20 education assistance program may be used by the department for the
- 21 purpose of promoting the program and for encouraging those persons
- 22 the department wishes to have enlist or reenlist in the Michigan
- 23 national quard.
- Sec. 213. The department shall consult with the house and
- 25 senate appropriations subcommittees on military and veterans
- 26 affairs regarding the projected closing or consolidation of any
- 27 national quard armories.

- 1 Sec. 214. It is the intent of the legislature that, should the
- 2 necessary legislation be enacted and funding become available,
- 3 funds be appropriated for state military cemeteries in Crawford and
- 4 Dickinson Counties.
- 5 Sec. 221. From the funds appropriated in part 1 for
- 6 information technology, departments and agencies shall pay user
- 7 fees to the department of information technology for technology-
- 8 related services and projects. These user fees shall be subject to
- 9 provisions of an interagency agreement between the departments and
- 10 agencies and the department of information technology.
- 11 Sec. 223. Amounts appropriated in part 1 for information
- 12 technology may be designated as work projects and carried forward
- 13 to support technology projects under the direction of the
- 14 department of information technology. Funds designated in this
- 15 manner are not available for expenditure until approved as work
- 16 projects under section 451a of the management and budget act, 1984
- **17** PA 431, MCL 18.1451a.
- 18 Sec. 225. (1) Due to the current budgetary problems in this
- 19 state, out-of-state travel for the fiscal year ending September 30,
- 20 2007 shall be limited to situations in which 1 or more of the
- 21 following conditions apply:
- 22 (a) The travel is required by legal mandate or court order or
- 23 for law enforcement purposes.
- (b) The travel is necessary to protect the health or safety of
- 25 Michigan citizens or visitors or to assist other states in similar
- 26 circumstances.
- (c) The travel is necessary to produce budgetary savings or to

- 1 increase state revenues, including protecting existing federal
- 2 funds or securing additional federal funds.
- 3 (d) The travel is necessary to comply with federal
- 4 requirements.
- 5 (e) The travel is necessary to secure specialized training for
- 6 staff that is not available within this state.
- 7 (f) The travel is financed entirely by federal or nonstate
- 8 funds.
- 9 (2) If out-of-state travel is necessary but does not meet 1 or
- 10 more of the conditions in subsection (1), the state budget director
- 11 may grant an exception to allow the travel. Any exceptions granted
- 12 by the state budget director shall be reported on a monthly basis
- 13 to the senate and house of representatives standing committees on
- 14 appropriations.
- 15 (3) Not later than January 1 of each year, each department
- 16 shall prepare a travel report listing all travel by classified and
- 17 unclassified employees outside this state in the immediately
- 18 preceding fiscal year that was funded in whole or in part with
- 19 funds appropriated in the department's budget. The report shall be
- 20 submitted to the chairs and members of the senate and house of
- 21 representatives standing committees on appropriations, the fiscal
- 22 agencies, and the state budget director. The report shall include
- 23 the following information:
- 24 (a) The name of each person receiving reimbursement for travel
- 25 outside this state or whose travel costs were paid by this state.
- 26 (b) The destination of each travel occurrence.
- (c) The dates of each travel occurrence.

- 1 (d) A brief statement of the reason for each travel
- 2 occurrence.
- 3 (e) The transportation and related costs of each travel
- 4 occurrence, including the proportion funded with state general
- 5 fund/general purpose revenues, the proportion funded with state
- 6 restricted revenues, the proportion funded with federal revenues,
- 7 and the proportion funded with other revenues.
- 8 (f) A total of all out-of-state travel funded for the
- 9 immediately preceding fiscal year.
- 10 Sec. 226. The department shall not take disciplinary action
- 11 against an employee for communicating with a member of the
- 12 legislature or his or her staff.
- Sec. 227. Sixty days prior to the public announcement of the
- 14 intention to sell any department property, the department shall
- 15 submit notification of that intent to the appropriate senate and
- 16 house appropriations subcommittees and the senate and house fiscal
- 17 agencies.
- 18 Sec. 228. By October 15, 2006, the department shall provide to
- 19 the senate and house appropriations subcommittees on state police
- 20 and military and veterans affairs and the senate and house fiscal
- 21 agencies a list of general fund/general purpose budget cuts
- 22 sufficient to reduce department general fund/general purpose
- 23 spending by 7.93% in fiscal year 2006-2007 if the K-16 ballot
- 24 initiative is adopted by the voters of the state.

25 HEADQUARTERS AND ARMORIES

Sec. 301. The department may charge reasonable rental and

- 1 equipment usage fees for renting an armory or using the distance
- 2 learning network. The fee shall include the cost of overtime
- 3 compensation, insurance coverage, and any maintenance required.
- 4 Sec. 302. (1) The funds appropriated in this act for private
- 5 donations to the challenge program shall be considered state
- 6 restricted revenue, and unexpended funds remaining at the close of
- 7 the fiscal year shall not lapse to the general fund but shall be
- 8 carried forward to the subsequent fiscal year.
- 9 (2) The department shall make every effort to identify
- 10 alternative sources of revenue to replace the general fund/general
- 11 purpose funding provided in this act for the challenge program.
- 12 (3) The department may charge a parent or guardian of a
- 13 participant in the challenge program a fee for participating in the
- 14 program if the participant is a member of a family with an income
- 15 that exceeds 200% of the federal poverty guidelines as published by
- 16 the United States department of health and human services. The
- 17 amount charged the parent or guardian shall not exceed the per
- 18 student state share cost of administering the program. The parent
- 19 or guardian shall be notified of any charge to be assessed under
- 20 this subsection prior to enrollment of the child in the program.
- Sec. 303. From the funds appropriated in part 1 for the
- 22 challenge program, the department shall operate two classes of at
- 23 least 150 pupils each. The department shall utilize funding from
- 24 payments by school districts that receive funding through the
- 25 School Aid Act, that are appropriated in the School Aid Budget Bill
- 26 sections 22a, 22b, and 24c.
- 27 Sec. 304. The department will partner with the department of

- 1 human services to identify youth who may be eligible for the
- 2 challenge program from those youth served by department of human
- 3 services programs. These eligible youth shall be given priority for
- 4 enrollment in the program.

5 VETERANS SERVICE ORGANIZATIONS

- 6 Sec. 501. (1) Money appropriated in part 1 for grants to
- 7 veterans service organizations shall be used only for salaries,
- 8 wages, related personnel costs, training, and equipment for
- 9 accredited veteran service advocacy officers and necessary support
- 10 and managerial staff. Training shall be provided for service
- 11 advocacy officers and shall be conducted by accredited advocacy
- 12 officers.
- 13 (2) To receive a grant from the money appropriated in part 1,
- 14 a veterans service organization shall meet the following
- 15 eligibility requirements:
- 16 (a) Be congressionally chartered by the United States
- 17 congress.
- 18 (b) Be an active participating member of the Michigan veterans
- 19 organizations' rehabilitation and veterans service committee and
- 20 abide by its rules, guidelines, and programs.
- (c) Demonstrate the receipt of monetary or service support
- 22 from its own organization.
- 23 (d) Comply with the department's and the legislature's
- 24 requirements of accounting audits, service work activity,
- 25 accounting of recoveries, listing of volunteer hours, budget
- 26 requests, and other requirements specified in subsection (3).

- 1 (e) For a veterans service organization founded after
- 2 September 30, 1989, be in operation and providing service to
- 3 Michigan veterans for not less than 2 years before receiving an
- 4 initial state grant. During this 2-year period of time, the
- 5 organization shall file a listing of service work activity and an
- 6 accounting of recoveries with the department, the senate and house
- 7 fiscal agencies, the senate and house of representatives
- 8 appropriations subcommittees on military affairs, and the state
- 9 budget office on forms as prescribed by the department.
- 10 (3) A veterans service organization receiving a grant from the
- 11 money appropriated in part 1 shall file with the department an
- 12 accounting of its expenditures, audited and certified by a
- 13 certified public accountant, within 120 days after the
- 14 organization's fiscal year end. Each organization shall provide a
- 15 detailed budget request for the fiscal year ending September 30,
- 16 2008 to the department by November 15, 2006. Each veterans service
- 17 organization shall provide 5 copies of a listing of all service
- 18 activity, an accounting of recoveries, and a listing of volunteer
- 19 hours for the fiscal year ending September 30, 2006 to the
- 20 department by January 31, 2007. The listing of volunteer hours
- 21 shall include the hours, services, and donations provided to
- 22 residents of the Grand Rapids veterans' home and the D.J. Jacobetti
- 23 veterans' home. Each veterans service organization shall provide a
- 24 copy of the most recent and completed internal revenue service form
- 25 990 to the department at the end of the fiscal year ending
- 26 September 30, 2006. A veterans service organization receiving a
- 27 grant from the money appropriated in part 1 shall use the forms

- 1 recommended by the Michigan veterans organizations rehabilitation
- 2 and veterans service committee for filing reports required by this
- 3 article. The department shall forward information required under
- 4 this section to the senate and house fiscal agencies, the senate
- 5 and house of representatives appropriations subcommittees on
- 6 military affairs, and the state budget office.
- 7 (4) The veterans service directors committee and the
- 8 department shall take steps to improve the coordination of veterans
- 9 benefits counseling in the state to maximize the effective and
- 10 efficient use of taxpayer dollars in this goal and to ensure that
- 11 every veteran is served.
- 12 (5) To accomplish the goal of subsection (4), the veterans
- 13 service directors committee and the department shall take steps to
- 14 increase their responsibility in the administration, management,
- 15 oversight, and outreach of the delivery of services to veterans.
- 16 The veterans service directors committee and the department shall
- 17 involve county veterans counselors and representatives from the
- 18 Michigan veterans trust fund to work in concert to identify,
- 19 implement, and evaluate steps to do all of the following:
- 20 (a) Increase the veterans service directors committee and the
- 21 department's role in working directly with the United States
- 22 department of veterans' affairs to enhance the delivery of services
- 23 to Michigan veterans.
- 24 (b) Increase the number of initial claims filed with the
- 25 United States department of veterans' affairs on behalf of veterans
- 26 for service-connected disability or pension benefits. The veterans
- 27 service directors committee and the department may work toward

- 1 either an absolute increase of approved claims or an increase in
- 2 the percentage of Michigan veterans with approved claims.
- 3 (c) Develop methods to increase rates of recovery paid by the
- 4 United States department of veterans' affairs to Michigan veterans
- 5 either by an increase in compensation paid per approved claim or
- 6 increase in compensation paid on a per capita basis.
- 7 (d) Expand training opportunities for veterans service
- 8 organization service officers.
- 9 (e) Increase either the number or percentage of Michigan
- 10 veterans enrolled in the VA healthcare system.
- 11 (f) Publicize the availability, benefit, and value of burial

- (g) Review each grant recipient's performance under the
- 14 program and require that performance be a major consideration in
- 15 the future funding of each grant recipient.
- 16 (h) Identify areas of redundancy which may exist among
- 17 services provided by veterans service organizations grantees,
- 18 Michigan veterans trust fund county committees, and county veterans
- 19 counselors and provide a proposal on how any redundancies may be
- 20 minimized and identify specific cost savings which could result.
- 21 (6) The veterans service directors committee and the
- 22 department shall create a report of the efforts to complete the
- 23 goals outlined in this section and shall provide suggestions on how

VETERANS' HOMES

- 2 Sec. 601. Appropriations in this act for the Grand Rapids
- 3 veterans' home and the D.J. Jacobetti veterans' home shall not be
- 4 used for any purpose other than for veterans and veterans'
- 5 families.

- 6 Sec. 602. The Grand Rapids veterans' home and the D.J.
- 7 Jacobetti veterans' home, together with the department and the
- 8 department of management and budget, shall produce and deliver to
- 9 the senate and house of representatives appropriations
- 10 subcommittees on state police and military affairs an annual
- 11 written report. The report shall include an accounting of member
- 12 populations and bed space available; a description and accounting
- 13 of services and activities provided to members; financial
