THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 8801. (1) This chapter applies only to a state civil
- 2 infraction action involving a violation of state law that is
- 3 designated as a state civil infraction.
- 4 (2) This chapter does not apply to a civil infraction action5 involving a traffic or parking violation.
 - (3) As used in this chapter:
 - (a) "Citation" means a written complaint or notice to appear
 - in court upon which a law enforcement officer records the
 - occurrence or existence of 1 or more state civil infractions by the
