A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 601b (MCL 257.601b), as amended by 2003 PA 314.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 601b. (1) Notwithstanding any other provision of this

 act, a person responsible for a moving violation in a work zone, at

 an emergency scene, or in a school zone during the period beginning

 minutes before school in the morning and through 30 minutes

 after school in the afternoon is subject to a fine that is double

 the fine otherwise prescribed for that moving violation.
 - (2) A person who commits a moving violation IN A WORK ZONE for which not fewer than 3 points are assigned under section 320a and as a result causes injury to $\frac{1}{4}$ ANOTHER person $\frac{1}{4}$ working in the

- 2 more than \$1,000.00 or imprisonment for not more than 1 year, or
- 3 both.
- 4 (3) A person who commits a moving violation IN A WORK ZONE for

- 6 as a result causes death to -a ANOTHER person -working in the
- 7 work zone is guilty of a felony punishable by a fine of not more
