 SCHOOL AID PAYMENTS UNDER THIS ACT UNTIL THE RECORD DESCRIBED IN
 THIS SECTION IS MADE AVAILABLE AS REQUIRED UNDER SUBSECTION (2).
 - (2) A DISTRICT OR INTERMEDIATE DISTRICT SHALL MAKE A RECORD OF INFORMATION CONCERNING EACH MOTOR VEHICLE THAT IT OWNS OR LEASES AVAILABLE TO THE PUBLIC BY TRANSMITTING THE INFORMATION TO THE DEPARTMENT OF MANAGEMENT AND BUDGET FOR POSTING ON A WEBSITE THAT
