- 1 SEC. 1278A. (1) BEGINNING WITH PUPILS SCHEDULED TO GRADUATE
- 2 FROM HIGH SCHOOL IN 2010, AND SUBJECT TO SUBSECTION (3), THE BOARD
- 3 OF A SCHOOL DISTRICT OR BOARD OF DIRECTORS OF A PUBLIC SCHOOL
- 4 ACADEMY SHALL NOT AWARD A HIGH SCHOOL DIPLOMA TO A PUPIL UNLESS THE
- 5 PUPIL MEETS ALL OF THE FOLLOWING:
- 6 (A) HAS COMPLETED ALL SUBJECT AREA ASSESSMENTS UNDER SECTION
- 7 1279 OR THE MICHIGAN MERIT EXAMINATION UNDER SECTION 1279G, AS
- 8 APPLICABLE TO THE PUPIL UNDER SECTION 1279G, OR HAS PARTICIPATED IN
 - THE MIACCESS ASSESSMENTS FOR PUPILS NEEDING SPECIAL EDUCATION

- 2 (B) HAS SUCCESSFULLY COMPLETED THE COURSE CREDIT REQUIREMENTS
- 3 OF THE MICHIGAN MERIT CURRICULUM AS PART OF HIS OR HER HIGH SCHOOL

- 19 (3) THE REQUIREMENTS OF SUBSECTION (1) ARE SUBJECT TO BOTH OF

- 11 INSTRUCTIONAL DELIVERY METHODS SUCH AS ALTERNATIVE COURSE WORK,
- 12 CAREER AND TECHNICAL EDUCATION, OR HUMANITIES COURSE SEQUENCES, IF
- 13 THESE ALTERNATIVE DELIVERY METHODS ARE APPROVED BY THE DEPARTMENT.
- 14 (5) IF A SCHOOL DISTRICT OR PUBLIC SCHOOL ACADEMY IS UNABLE TO
- 15 IMPLEMENT ALL OF THE REQUIREMENTS OF THIS SECTION FOR PUPILS
- 16 SCHEDULED TO GRADUATE IN 2010, THE SCHOOL DISTRICT OR PUBLIC SCHOOL
- 17 ACADEMY MAY APPLY TO THE DEPARTMENT FOR PERMISSION TO PHASE IN THE
- 18 REQUIREMENTS OF THIS SECTION. TO APPLY, THE SCHOOL DISTRICT OR
- 19 PUBLIC SCHOOL ACADEMY SHALL SUBMIT A PROPOSED PHASE-IN PLAN TO THE
- 20 DEPARTMENT. THE DEPARTMENT SHALL APPROVE A PHASE-IN PLAN IF THE
- 21 DEPARTMENT DETERMINES THAT THE PLAN WILL RESULT IN THE SCHOOL
- 22 DISTRICT OR PUBLIC SCHOOL ACADEMY MAKING SATISFACTORY PROGRESS
- 23 TOWARD FULL IMPLEMENTATION OF THE REQUIREMENTS OF THIS SECTION. IF
- 24 THE DEPARTMENT DISAPPROVES A PROPOSED PHASE-IN PLAN, THE DEPARTMENT
- 25 SHALL WORK WITH THE SCHOOL DISTRICT OR PUBLIC SCHOOL ACADEMY TO
- 26 DEVELOP A SATISFACTORY PLAN THAT MAY BE APPROVED.
