A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 803e (MCL 257.803e), as amended by 2003 PA 30.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 803e. (1) A person who has been a prisoner of war or a person whose spouse has been a prisoner of war may make application to the secretary of state for a special registration plate —which THAT shall be inscribed with special identification numbers preceded by the letters "EX-POW" and shall have the words "exprisoner of war" inscribed beneath the registration number.

(2) A person who was a member of the armed services during
World War I may make application to the secretary of state for a
special registration plate —, which— THAT shall be inscribed with

- 1 special identification numbers preceded by the letters "WWI" and
- 2 shall have the words "World War I veteran" inscribed beneath the
- 3 registration number.
- 4 (3) A person who was a member of the armed services during
- 5 1941, stationed at a United States military or naval establishment
- 6 at Pearl Harbor in the Hawaiian islands, and who survived the
- 7 attack by Japan on Pearl Harbor on December 7, 1941 may make
- 8 application to the secretary of state for a special registration
- 9 plate -, which THAT shall be inscribed with special identification
- 10 numbers and shall have the words "Pearl Harbor survivor" inscribed
- 11 beneath the registration number.
- 12 (4) A person who is a recipient of the purple heart medal may
- 13 make application to the secretary of state for a special
- 14 registration plate -which- THAT shall be inscribed with special
- 15 identification numbers and shall have the words "combat wounded
- 16 veteran" inscribed beneath the registration number. In addition,
- 17 the special registration plate described under this subsection
- 18 shall be inscribed with a vignette of the official purple heart
- 19 medal.
- 20 (5) A PERSON WHO IS A RECIPIENT OF A BRONZE SERVICE STAR MAY
- 21 MAKE APPLICATION TO THE SECRETARY OF STATE FOR A SPECIAL
- 22 REGISTRATION PLATE THAT SHALL BE INSCRIBED WITH SPECIAL
- 23 IDENTIFICATION NUMBERS AND SHALL HAVE THE WORDS "BRONZE SERVICE
- 24 STAR VETERAN" INSCRIBED BENEATH THE REGISTRATION NUMBER. IN

- 17 (8) -(6) Upon proper application and payment of the \$5.00
- 18 service fee, the secretary of state shall issue 1 or more special
- 19 registration plates for each applicant for use on a passenger
- 20 vehicle. A person who is disabled who makes application for a
- 21 special registration plate under this section and who makes payment
- 22 of the \$5.00 service fee shall be issued a tab for persons with
- 23 disabilities as provided in section 803f for his or her special

- 1 issued under subsection (1) that is exempt from payment of the tax

- 8 other than the vehicle for which the plate is issued, or by a

- 10 (10) $\overline{(8)}$ The special registration plate issued under this
- 11 section expires on the birthday of the vehicle owner in a year in
- 12 which new plates are issued by the secretary of state. Application
- 13 for renewal of the special registration plate shall be accompanied
- 14 by a \$5.00 service fee. The applicant is not required to furnish
- 15 the proof provided in subsection -(5) (7).
