THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 310F. (1) THE SECRETARY OF STATE SHALL ESTABLISH A
- 2 VOLUNTARY YOUTHFUL DRIVER MONITORING PROGRAM TO PROVIDE INFORMATION
- 3 TO THE PARENTS AND LEGAL GUARDIANS OF YOUTHFUL DRIVERS.
- 4 (2) THE PROGRAM SHALL INCLUDE ALL OF THE FOLLOWING:
- 5 (A) A PLACARD OR DECAL FOR DISPLAY ON THE EXTERIOR OF A MOTOR
- 6 VEHICLE THAT INCLUDES A NUMBER THAT IS UNIQUELY IDENTIFIABLE TO A
- 7 YOUTHFUL DRIVER. THE PLACARD OR DECAL SHALL ALSO INCLUDE TOLL-FREE
 - CONTACT INFORMATION THAT ALLOWS AN OBSERVER TO REPORT DRIVING

- 2 (B) AN INFORMATION COLLECTION SERVICE FOR REPORTS CONCERNING

- 26 (B) "YOUTHFUL DRIVER" MEANS AN INDIVIDUAL WHO IS LESS THAN 18
- 27 YEARS OLD AND WHO HOLDS A GRADUATED DRIVER LICENSE UNDER SECTION
