February 17, 2005, Introduced by Senators GILBERT, VAN WOERKOM, BIRKHOLZ, SANBORN, CROPSEY, GOSCHKA, ALLEN, STAMAS, HARDIMAN, GARCIA, BROWN, JELINEK and BARCIA and referred to the Committee on Agriculture, Forestry and Tourism.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding part 23.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 PART 23. AGRICULTURE AND THE ENVIRONMENT
- 2 SEC. 2301. AS USED IN THIS PART:
- 3 (A) "COUNCIL" MEANS THE AGRICULTURE AND RURAL COMMUNITIES
 - ADVISORY COUNCIL CREATED IN SECTION 2302.
 - (B) "DEPARTMENT" MEANS THE DEPARTMENT OF ENVIRONMENTAL
- OUALITY.
 - SEC. 2302. (1) THE AGRICULTURE AND RURAL COMMUNITIES ADVISORY
- COUNCIL IS CREATED WITHIN THE DEPARTMENT.
 - (2) THE COUNCIL SHALL CONSIST OF THE FOLLOWING MEMBERS:

- 1 (A) TWO INDIVIDUALS REPRESENTING FARMERS, 1 OF WHOM SHALL BE
- 2 APPOINTED BY THE SENATE MAJORITY LEADER AND 1 OF WHOM SHALL BE

- 12 (3) THE MEMBERS FIRST APPOINTED TO THE COUNCIL SHALL BE
- 13 APPOINTED WITHIN 60 DAYS AFTER THE EFFECTIVE DATE OF THE AMENDATORY

- 23 (C) THE MEMBER FIRST APPOINTED BY THE SPEAKER OF THE HOUSE OF
- 24 REPRESENTATIVES UNDER SUBSECTION (2) (C) SHALL SERVE FOR A TERM OF 2
- 25 YEARS.
- 26 (D) THE MEMBER FIRST APPOINTED BY THE SENATE MAJORITY LEADER
- 27 UNDER SUBSECTION (2)(D) SHALL SERVE FOR A TERM OF 2 YEARS.

- 1 (5) IF A VACANCY OCCURS ON THE COUNCIL, THE GOVERNOR SHALL
- 2 MAKE AN APPOINTMENT FOR THE UNEXPIRED TERM IN THE SAME MANNER AS
- 3 THE ORIGINAL APPOINTMENT.
- 4 (6) A MEMBER OF THE COUNCIL MAY BE REMOVED, BY THE OFFICER WHO
- 5 APPOINTED THAT MEMBER, FOR INCOMPETENCY, DERELICTION OF DUTY,
- 6 MALFEASANCE, MISFEASANCE, OR NONFEASANCE IN OFFICE, OR ANY OTHER
- 7 GOOD CAUSE.
- 8 SEC. 2303. (1) THE FIRST MEETING OF THE COUNCIL SHALL BE
- 9 CALLED BY THE SENATE MAJORITY LEADER. AT THE FIRST MEETING, THE
- 10 COUNCIL SHALL ELECT FROM AMONG ITS MEMBERS A CHAIRPERSON AND OTHER
- 11 OFFICERS AS IT CONSIDERS NECESSARY OR APPROPRIATE. AFTER THE FIRST
- 12 MEETING, THE COUNCIL SHALL MEET AT LEAST 2 TIMES PER YEAR, OR MORE
- 13 FREQUENTLY AT THE CALL OF THE CHAIRPERSON OR IF REQUESTED BY 3 OR
- 14 MORE MEMBERS.
- 15 (2) A MAJORITY OF THE MEMBERS OF THE COUNCIL CONSTITUTE A

- 22 (4) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF, OR

- 24 IS SUBJECT TO THE FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL

- 26 (5) MEMBERS OF THE COUNCIL SHALL SERVE WITHOUT COMPENSATION.
- 27 HOWEVER, MEMBERS OF THE COUNCIL MAY BE REIMBURSED FOR THEIR ACTUAL

- 10 AND RECOMMENDATIONS ON THE LAWS, RULES, AND POLICIES ADMINISTERED
- 11 BY THE DEPARTMENT THAT AFFECT FARMERS, FOOD PROCESSORS,
- 12 AGRIBUSINESS, AND RURAL COMMUNITIES.
- 13 (2) THE DEPARTMENT SHALL PROVIDE STAFF AND ASSISTANCE TO THE
- 14 COUNCIL AS NECESSARY OR USEFUL FOR THE COUNCIL TO CARRY OUT ITS
- 15 RESPONSIBILITIES.
