## **SENATE BILL No. 375**

April 13, 2005, Introduced by Senators McMANUS, PATTERSON, CROPSEY, BASHAM, BARCIA, GOSCHKA, GILBERT, BIRKHOLZ, JELINEK, TOY, SANBORN, ALLEN, BISHOP and STAMAS and referred to the Committee on Government Operations.

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms and gas ejecting devices; to prohibit the buying, selling, or carrying of certain firearms and gas ejecting devices without a license or other authorization; to provide for the forfeiture of firearms under certain circumstances; to provide for penalties and remedies; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; to prohibit certain conduct against individuals who apply for or receive a license to carry a concealed pistol; to make appropriations; to prescribe certain conditions for the appropriations; and to repeal all acts and parts of acts inconsistent with this act,"

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4. (1) A person who is prohibited from possessing, using,
- 2 transporting, selling, purchasing, carrying, shipping, receiving,
- 3 or distributing a firearm under section 224f(2) of the Michigan
- 4 penal code, Act No. 328 of the Public Acts of 1931, being section
- 5 750.224f of the Michigan Compiled Laws 1931 PA 328, MCL 750.224F,
- 6 may apply to the -concealed weapons licensing board in the county
- 7 in which he or she resides SECRETARY OF STATE for restoration of
- 8 those rights.
- 9 (2) Not more than 1 application may be submitted under
- 10 subsection (1) in any calendar year. The -concealed weapons
- 11 licensing board SECRETARY OF STATE may charge a fee of not more
- 12 than \$10.00 for the actual and necessary expenses of each
- 13 application.
- 14 (3) The <u>concealed weapons licensing board</u> SECRETARY OF STATE
- 15 shall, by written order, of the board, restore the rights of a
- 16 person to possess, use, transport, sell, purchase, carry, ship,
- 17 receive, or distribute a firearm if the board SECRETARY OF STATE
- 18 determines, by clear and convincing evidence, that all of the
- 19 following circumstances exist:
- (a) The person properly submitted an application for
- 21 restoration of those rights as provided under this section.
- 22 (b) The expiration of 5 years after all of the following
- 23 circumstances:

- 1 (i) The person has paid all fines imposed for the violation
- 2 resulting in the prohibition.
- 3 (ii) The person has served all terms of imprisonment imposed
- 4 for the violation resulting in the prohibition.
- 5 (iii) The person has successfully completed all conditions of
- 6 probation or parole imposed for the violation resulting in the
- 7 prohibition.
- 8 (c) The person's record and reputation are such that the
- 9 person is not likely to act in a manner dangerous to the safety of
- 10 other persons.
- 11 (4) If the <u>concealed weapons licensing board</u> SECRETARY OF
- 12 STATE pursuant to subsection (3) refuses to restore a right under
- 13 this section, the person may petition the circuit court for review
- 14 of that decision.
- 15 Sec. 5. (1) County sheriffs, local police agencies, and county
- 16 clerks shall provide concealed pistol application kits during
- 17 normal business hours and free of charge to individuals who wish to
- 18 apply for licenses to carry concealed pistols. Each kit shall only
- 19 contain all of the following:
- 20 (a) A concealed pistol license application form provided by
- 21 the director of the department of state police.
- 22 (b) The fingerprint cards required under section  $\frac{-5b(11)}{}$  5B.
- 23 (c) Written information regarding the procedures involved in
- 24 obtaining a license to carry a concealed pistol, including
- 25 information regarding the right to appeal the denial of a license
- 26 and the form required for that appeal.
- 27 (d) Written information identifying entities that offer the

- 1 training required under section  $\frac{-5b(7)(c)}{-5b}$ .
- 2 (2) A county sheriff, local police agency, or county clerk
- 3 shall not deny an individual the right to receive a concealed
- 4 pistol application kit under this section.
- 5 (3) An individual who is denied an application kit under this
- 6 section and obtains an order of mandamus directing the -concealed
- 7 weapon licensing board SECRETARY OF STATE to provide him or her
- 8 with the application kit shall be awarded his or her actual and
- 9 reasonable costs and attorney fees for obtaining the order.
- 10 (4) The department of state police shall provide the
- 11 application kits required under this section to county sheriffs,
- 12 local law enforcement agencies, and county clerks in sufficient
- 13 quantities to meet demand. The department of state police shall not
- 14 charge a fee for the kits.
- 15 Sec. 5a. (1) Each county shall have a concealed weapon
- 16 licensing board. The concealed weapon licensing board of each
- 17 county shall have the following members:
- 18 ————(a) The county prosecuting attorney or his or her designee.
- 19 However, if the county prosecuting attorney decides that he or she
- 20 does not want to be a member of the concealed weapon licensing
- 21 board, he or she shall notify the county board of commissioners in
- 22 writing that he or she does not want to be a member of the
- 23 concealed weapon licensing board for the balance of his or her term
- 24 in office. The county board of commissioners shall then appoint a
- 25 replacement for the prosecuting attorney who is a firearms
- 26 instructor who has the qualifications prescribed in section
- 27 5j(1)(c). The person who replaces the prosecuting attorney shall

- 1 serve on the concealed weapon licensing board in place of the
- 2 prosecuting attorney for the remaining term of the county
- 3 prosecuting attorney unless removed for cause by the county board
- 4 of commissioners. If a vacancy occurs on the concealed weapon
- 5 licensing board of the person appointed pursuant to this section
- 6 during the term of office of the county prosecuting attorney, the
- 7 county board of commissioners shall appoint a replacement person
- 8 who is a firearms instructor who has the qualifications prescribed
- 9  $\frac{in\ section\ 5i(1)(c)}{}$ .
- 10 (b) The county sheriff or his or her designee.
- 11 (c) The director of the department of state police or his or
- 12 her designee.
- 13 (2) If a prosecuting attorney chooses not to be a member of
- 14 the concealed weapon licensing board, all of the following apply:
- 15 (a) The prosecuting attorney shall be notified of all
- 16 applications received by the concealed weapon licensing board.
- 17 (b) The prosecuting attorney shall be given an opportunity to
- 18 object to granting a license to carry a concealed pistol and
- 19 present evidence bearing directly on an applicant's suitability to
- 20 carry a concealed pistol safely.
- 21 (c) The prosecuting attorney shall disclose to the concealed
- 22 weapon licensing board any information of which he or she has
- 23 actual knowledge that bears directly on an applicant's suitability
- 24 to carry a concealed pistol safely.
- 25 (3) The county prosecuting attorney or his or her designee
- 26 shall serve as chairperson of the board unless the prosecuting
- 27 attorney does not want to be a member of the concealed weapon

- 1 licensing board, in which case the concealed weapon licensing board
- 2 shall elect its chairperson. Two members of the concealed weapon
- 3 licensing board constitute a quorum of the concealed weapon
- 4 licensing board. The business of the concealed weapon licensing
- 5 board shall be conducted by a majority vote of all of the members
- 6 of the concealed weapon licensing board.
- 7 (4) The county clerk shall serve as the clerk of the concealed
- 8 weapon licensing board.
- 9 (1) -(5) Except as otherwise provided in this act, the
- 10 concealed weapon licensing board THE SECRETARY OF STATE has
- 11 exclusive authority to issue, deny, revoke, or suspend a license to
- 12 carry a concealed pistol. The -concealed weapon licensing board
- 13 SECRETARY OF STATE shall perform other duties CONCERNING CONCEALED
- 14 PISTOLS as provided by law.
- 15 (6) The concealed weapon licensing board may convene not more
- 16 than 3 panels to assist the board in evaluating applicants. The
- 17 panels shall be composed of representatives as prescribed in
- 18 subsection (1). The panels do not have the authority to issue,
- 19 deny, revoke, or suspend a license.
- 20 (2) (7) The -concealed weapon licensing board SECRETARY OF
- 21 STATE may investigate -the- AN applicant for a license to carry a
- 22 concealed pistol. The investigation shall be restricted to
- 23 determining only whether the applicant is eligible under this act
- 24 to receive a license to carry a concealed pistol, and the
- 25 investigation regarding the issuance of a license shall end after
- 26 that determination is made. The -concealed weapon licensing board
- 27 SECRETARY OF STATE may require the applicant to appear before the

- 1 board SECRETARY OF STATE at a mutually agreed-upon time for a
- 2 conference. The applicant's failure or refusal to appear without
- 3 valid reason before the -concealed weapon licensing board as
- 4 provided in this subsection SECRETARY OF STATE is grounds for the
- 5 board SECRETARY OF STATE to deny issuance of a license to carry a
- 6 concealed pistol to that applicant.
- 7 (3) -(8) If the -concealed weapon licensing board SECRETARY
- 8 OF STATE determines there is probable cause to believe the safety
- 9 of the applicant or the safety of a member of the applicant's
- 10 family is endangered by the applicant's inability to immediately
- 11 obtain a license to carry a concealed pistol, the -concealed weapon
- 12 licensing board SECRETARY OF STATE may, pending issuance of a
- 13 license, issue a temporary license to the individual to carry a
- 14 concealed pistol. A temporary license shall be on a form provided
- 15 by the department of state police. A temporary license shall be
- 16 unrestricted and shall be valid for not more than 180 days. A
- 17 temporary license may be renewed for 1 additional period of not
- 18 more than 180 days. A temporary license is, for all other purposes
- 19 of this act, a license to carry a concealed pistol.
- 20 (9) The legislative service bureau shall compile the firearms
- 21 laws of this state, including laws that apply to carrying a
- 22 concealed pistol, and shall provide copies of the compilation to
- 23 each concealed weapon licensing board in this state for
- 24 distribution under this subsection. A concealed weapon licensing
- 25 board shall distribute a copy of the compilation to each individual
- 26 who applies for a license to carry a concealed pistol at the time
- 27 the application is submitted. The concealed weapon licensing board

- 1 shall require the applicant to sign a written statement
- 2 acknowledging that he or she has received a copy of the
- 3 compilation. An individual is not eligible to receive a license to
- 4 carry a concealed pistol until he or she has signed the statement.
- 5 Sec. 5b. (1) To obtain a license to carry a concealed pistol,
- 6 an individual shall apply to the -concealed weapon licensing board
- 7 in the county in which that individual resides SECRETARY OF STATE.
- 8 The application shall be filed -with the county clerk during -the
- 9 county clerk's normal business hours. The application shall be on
- 10 a form provided by the -director of the department of state police
- 11 SECRETARY OF STATE and shall allow the applicant to -designate
- 12 whether INDICATE THAT the applicant seeks a temporary license. The
- 13 application shall be signed under oath by the applicant. The oath
- 14 shall be administered by the -county clerk SECRETARY OF STATE or
- 15 his or her representative. The application shall contain all of the
- 16 following: -information:
- 17 (a) The applicant's legal name and date of birth and the
- 18 address of his or her primary residence. If the applicant resides
- 19 in a city, village, or township that has a police department, the
- 20 name of the police department.
- 21 (b) A statement by the applicant that the applicant meets the
- 22 criteria for a license under this act to carry a concealed pistol.
- 23 (c) A statement by the applicant authorizing the -concealed
- 24 weapon licensing board SECRETARY OF STATE to access any record,
- 25 including any medical record, pertaining to the applicant's
- 26 qualifications for a license to carry a concealed pistol under this
- 27 act. The applicant may request that information received by the

- 1 concealed weapon licensing board SECRETARY OF STATE under this
- 2 subdivision be reviewed in a closed session. If the applicant
- 3 requests that the session be closed, the -concealed weapon
- 4 licensing board SECRETARY OF STATE shall close the session only
- 5 for purposes of this subdivision. The applicant and his or her
- 6 representative have the right to be present in the closed session.
- 7 Medical records and personal identifying information received by
- 8 the -concealed weapon licensing board SECRETARY OF STATE under
- 9 this subdivision is confidential, is not subject to disclosure
- 10 under the freedom of information act, 1976 PA 442, MCL 15.231 to
- 11 15.246, and shall not be disclosed to any person except for
- 12 purposes of this act or for law enforcement purposes or if the
- 13 applicant is convicted of a felony involving a pistol.
- 14 (d) A statement by the applicant regarding whether he or she
- 15 has a history of mental illness that would disqualify him or her
- 16 under subsection (7)(j) to (l) from receiving a license to carry a
- 17 concealed pistol, and authorizing the -concealed weapon licensing
- 18 board SECRETARY OF STATE to access the mental health records of
- 19 the applicant relating to his or her mental health history. The
- 20 applicant may request that information received by the -concealed
- 21 weapon licensing board SECRETARY OF STATE under this subdivision
- 22 be reviewed in a closed session. If the applicant requests that the
- 23 session be closed, the -concealed weapon licensing board SECRETARY
- 24 OF STATE shall close the session only for purposes of this
- 25 subdivision. The applicant and his or her representative have the
- 26 right to be present in the closed session. Medical records and
- 27 personal identifying information received by the -concealed weapon

- 1 licensing board SECRETARY OF STATE under this subdivision is
- 2 confidential, is not subject to disclosure under the freedom of
- 3 information act, 1976 PA 442, MCL 15.231 to 15.246, and shall not
- 4 be disclosed to any person except for purposes of this act or for
- 5 law enforcement purposes.
- 6 (e) A statement by the applicant regarding whether he or she
- 7 has ever been convicted in this state or elsewhere for any felony
- 8 or misdemeanor.
- 9 (f) A statement by the applicant whether he or she has been
- 10 dishonorably discharged from the United States armed forces.
- 11 (g) If the applicant seeks a temporary license, the facts
- 12 supporting the issuance of that temporary license.
- 13 (h) The names, residential addresses, and telephone numbers of
- 14 2 individuals who are references for the applicant.
- (i) A passport-quality photograph of the applicant provided by
- 16 the applicant at the time of application.
- 17 (j) A certificate stating that the applicant has completed the
- 18 training course prescribed by this act.
- 19 (2) The application form shall contain a conspicuous warning
- 20 that the application is executed under oath and that intentionally
- 21 making a material false statement on the application is a felony
- 22 punishable by imprisonment for not more than 4 years or a fine of
- 23 not more than \$2,500.00, or both.
- 24 (3) An individual who intentionally makes a material false
- 25 statement on an application under subsection (1) is guilty of a
- 26 felony punishable by imprisonment for not more than 4 years or a
- 27 fine of not more than \$2,500.00, or both.

- 1 (4) The -concealed weapon licensing board SECRETARY OF STATE
- 2 shall retain a copy of each application for a license to carry a
- 3 concealed pistol as an official record. One year after the
- 4 expiration of a concealed pistol license, the -county clerk
- 5 SECRETARY OF STATE may destroy the record and maintain only a name
- 6 index of the record.
- 7 (5) Each applicant shall pay a fee of \$105.00 by any method of
- 8 payment accepted by that county THE SECRETARY OF STATE for
- 9 payments of other fees and penalties. Except for a local police
- 10 agency as provided in subsection (9), a unit of local government,
- 11 an agency of a unit of local government, or an agency or department
- 12 of this state shall not charge an additional fee, assessment, or
- 13 other amount in connection with a license under this section. The
- 14 fee shall be payable to the county. The county treasurer shall
- 15 deposit \$41.00 of each fee collected under this section in the
- 16 general fund of the county and credit \$26.00 of that deposit to the
- 17 credit of the county clerk and \$15.00 of that deposit to the credit
- 18 of the county sheriff and forward the balance to the state
- 19 treasurer. THE MONEY COLLECTED UNDER THIS SECTION SHALL BE
- 20 DEPOSITED IN THE STATE TREASURY. The state treasurer shall deposit
- 21 the balance of the fee in the general fund to the credit of the
- 22 department of state police. The department of state police shall
- 23 use the money received under this act to process the fingerprints
- 24 and to reimburse the federal bureau of investigation for the costs
- 25 associated with processing fingerprints submitted under this act.
- 26 The balance of the money received under this act shall be credited
- 27 to the department of state police.

- 1 (6) The -county sheriff on behalf of the concealed weapon
- 2 licensing board DEPARTMENT OF STATE POLICE shall verify the
- 3 requirements of subsection (7)(d), (e), (f), (h), (i), (j), (k),
- $\mathbf{4}$  (l), and (m) through the law enforcement information network and
- 5 report his or her THE finding to the concealed weapon licensing
- 6 board SECRETARY OF STATE. If the applicant resides in a city,
- 7 village, or township that has a police department, the -concealed
- 8 weapon licensing board SECRETARY OF STATE shall contact that city,
- 9 village, or township police department to determine only whether
- 10 that city, village, or township police department has any
- 11 information relevant to the investigation of whether the applicant
- 12 is eligible under this act to receive a license to carry a
- 13 concealed pistol.
- 14 (7) The <u>concealed weapon licensing board</u> SECRETARY OF STATE
- 15 shall issue a license to an applicant to carry a concealed pistol
- 16 within the period required under this act after the applicant
- 17 properly submits an application under subsection (1) and the
- 18 concealed weapon licensing board SECRETARY OF STATE determines
- 19 that all of the following circumstances exist:
- (a) The applicant is 21 years of age or older.
- 21 (b) The applicant is a citizen of the United States or is a
- 22 resident legal alien, as defined in section 11 of title 18 of the
- 23 United States Code, is a resident of this state, and has resided
- 24 in this state for at least 6 months. The -concealed weapon
- 25 licensing board SECRETARY OF STATE may waive the 6-month residency
- 26 requirement for a temporary license under section -5a(8) 5A(3) if
- 27 the -concealed weapon licensing board- SECRETARY OF STATE

- 1 determines there is probable cause to believe the safety of the
- 2 applicant or the safety of a member of the applicant's family is
- 3 endangered by the applicant's inability to immediately obtain a
- 4 license to carry a concealed pistol.
- 5 (c) The applicant has knowledge and has had training in the
- 6 safe use and handling of a pistol by the successful completion of a
- 7 pistol safety training course or class that meets the requirements
- 8 of section 5j, and that is available to the general public and
- 9 presented by a law enforcement agency, junior or community college,
- 10 college, or public or private institution or organization or
- 11 firearms training school.
- 12 (d) The applicant is not the subject of an order or
- 13 disposition under any of the following:
- 14 (i) Section 464a of the mental health code, 1974 PA 258, MCL
- **15** 330.1464a.
- 16 (ii) Section 5107 of the estates and protected individuals
- 17 code, 1998 PA 386, MCL 700.5107.
- 18 (iii) Sections 2950 and 2950a of the revised judicature act of
- 19 1961, 1961 PA 236, MCL 600.2950 and 600.2950a.
- 20 (iv) Section 6b of chapter V of the code of criminal procedure,
- 21 1927 PA 175, MCL 765.6b, if the order has a condition imposed
- 22 pursuant to section 6b(3) of chapter V of the code of criminal
- 23 procedure, 1927 PA 175, MCL 765.6b.
- 24 (v) Section 16b of chapter IX of the code of criminal
- 25 procedure, 1927 PA 175, MCL 769.16b.
- (e) The applicant is not prohibited from possessing, using,
- 27 transporting, selling, purchasing, carrying, shipping, receiving,

- 1 or distributing a firearm under section 224f of the Michigan penal
- 2 code, 1931 PA 328, MCL 750.224f.
- 3 (f) The applicant has never been convicted of a felony in this
- 4 state or elsewhere, and a felony charge against the applicant is
- 5 not pending in this state or elsewhere at the time he or she
- 6 applies for a license described in this section.
- 7 (q) The applicant has not been dishonorably discharged from
- 8 the United States armed forces.
- 9 (h) The applicant has not been convicted of a misdemeanor
- 10 violation of any of the following in the 8 years immediately
- 11 preceding the date of application:
- 12 (i) Section 617a of the Michigan vehicle code, 1949 PA 300, MCL
- 13 257.617a (failing to stop when involved in a personal injury
- 14 accident).
- 15 (ii) Section 625 of the Michigan vehicle code, 1949 PA 300, MCL
- 16 257.625, punishable as provided in -subsection (8)(b) of that
