## **SENATE BILL No. 1167**

March 16, 2006, Introduced by Senators JELINEK, VAN WOERKOM, BIRKHOLZ, HARDIMAN, CROPSEY, KUIPERS, BROWN, GILBERT, BARCIA, ALLEN and GOSCHKA and referred to the Committee on Agriculture, Forestry and Tourism.

A bill to amend 2000 PA 322, entitled "Julian-Stille value-added act,"

(MCL 285.301 to 285.304) by adding section 2b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2B. (1) THE DIRECTOR OF THE DEPARTMENT SHALL CONVENE AN
- 2 AGRICULTURAL VALUE-ADDED COMMERCIALIZATION ROUNDTABLE TO DISCUSS
- 3 ALL FACETS OF THE COMMERCIALIZATION OF AGRICULTURAL PRODUCTS,
- 4 PROCESSES, AND SERVICES, INCLUDING, BUT NOT LIMITED TO, THE
- 5 AVAILABILITY OF CAPITAL, INNOVATION INFRASTRUCTURE, AND UNIVERSITY
- 6 LICENSING OF AGRICULTURAL RESEARCH. THE DIRECTOR OF THE DEPARTMENT
- 7 SHALL INVITE AT LEAST ALL OF THE FOLLOWING TO PARTICIPATE IN THE
- 8 ROUNDTABLE:
- 9 (A) THREE INDIVIDUALS FROM AN ASSOCIATION REPRESENTING
- 10 FARMERS.

- 1 (B) TWO INDIVIDUALS FROM AN ASSOCIATION REPRESENTING FOOD
- 2 PROCESSORS.
- 3 (C) TWO INDIVIDUALS FROM AN ASSOCIATION REPRESENTING
- 4 AGRIBUSINESS.
- 5 (D) TWO INDIVIDUALS REPRESENTING AGRICULTURAL LENDING
- 6 INSTITUTIONS.
- 7 (E) ONE INDIVIDUAL REPRESENTING MICHIGAN STATE UNIVERSITY.
- 8 (2) THE FIRST MEETING OF THE ROUNDTABLE SHALL BE CONVENED BY
- 9 THE DIRECTOR OF THE DEPARTMENT WITHIN 90 DAYS AFTER THE EFFECTIVE
- 10 DATE OF THIS SECTION. THE DIRECTOR OF THE DEPARTMENT SHALL CONVENE
- 11 THE ROUNDTABLE AT LEAST TWICE EACH CALENDAR YEAR, EXCEPT THAT IF
- 12 THIS SECTION TAKES EFFECT AFTER SEPTEMBER 30, THE ROUNDTABLE SHALL
- 13 CONVENE AT LEAST ONCE THE FIRST CALENDAR YEAR. THE ROUNDTABLE MAY
- 14 ADVISE THE DIRECTOR OF THE DEPARTMENT ON THE NEED FOR A MORE
- 15 FREQUENT MEETING SCHEDULE. THE MEETINGS OF THE ROUNDTABLE SHALL BE
- 16 OPEN TO THE GENERAL PUBLIC AND SHALL BE HELD IN A PLACE AVAILABLE
- 17 TO THE GENERAL PUBLIC. THE DEPARTMENT SHALL PROVIDE NOTICE OF EACH
- 18 MEETING OF THE ROUNDTABLE BY POSTING ON THE DEPARTMENT WEBSITE AND
- 19 SUCH OTHER MEANS AS THE DEPARTMENT DETERMINES APPROPRIATE. AT LEAST
- 20 1 MEETING OF THE ROUNDTABLE EACH YEAR SHALL BE HELD IN A RURAL
- 21 COMMUNITY. AT SUCH A MEETING, THE PUBLIC SHALL BE PROVIDED AN
- 22 OPPORTUNITY TO ADDRESS THE ROUNDTABLE ON ISSUES WITHIN ITS PURVIEW.
- 23 THE DEPARTMENT SHALL PREPARE A SUMMARY OF EACH MEETING OF THE
- 24 ROUNDTABLE INCLUDING A DEPARTMENT RESPONSE TO ISSUES RAISED DURING
- 25 THE ROUNDTABLE MEETING. THE DEPARTMENT SHALL DO BOTH OF THE
- 26 FOLLOWING:
- 27 (A) POST THE SUMMARY ON ITS WEBSITE.

4	DEALING PRIMARILY WITH AGRICULTURAL ISSUES.
