A bill to amend 1984 PA 270, entitled "Michigan strategic fund act,"

(MCL 125.2001 to 125.2094) by adding chapter 7A.

1 CHAPTER 7A

- 2 SEC. 79. (1) THE IN-STATE MICHIGAN VACATION PROGRAM CENTER IS
- 3 CREATED IN THE FUND. THE BOARD OF THE FUND SHALL IMPLEMENT AND

 - (2) THE CENTER SHALL CREATE AND OPERATE THE IN-STATE MICHIGAN
- 6 VACATION PROGRAM THAT DOES ALL OF THE FOLLOWING:
- 7 (A) UTILIZES A VOUCHER THAT CAN BE REDEEMED AT QUALIFIED
- 8 ACCOMMODATIONS.
 - (B) PROMOTES AND ADVERTISES THE PROGRAM TO RESIDENTS IN THIS

- 1 STATE AND TO POTENTIAL QUALIFIED ACCOMMODATIONS.

- 19 (B) "PROGRAM" MEANS THE IN-STATE MICHIGAN VACATION PROGRAM
- 20 CREATED AND OPERATED BY THE CENTER.
- 21 (C) "QUALIFIED ACCOMMODATION" MEANS A HOTEL, MOTEL, INN,
