SENATE BILL No. 1290

June 7, 2006, Introduced by Senator GILBERT and referred to the Committee on Transportation.

A bill to provide for the certification of driver education providers; to prescribe certain record-keeping and program requirements for driver education providers; to provide for the certification of driver education instructors; to prescribe the powers and duties of certain persons and departments; to prescribe certain fees; to establish a fund in the state treasury; to prescribe remedies, sanctions, and penalties; and to repeal acts, administrative rules, and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as the "driver education provider and instructor act".
 - Sec. 3. As used in this act:
 - (a) "Adult driver training" means instruction that is provided

- 1 to a person 18 years of age or older in the operation of a motor
- 2 vehicle, other than a commercial motor vehicle as defined in
- 3 section 7a of the Michigan vehicle code, 1949 PA 300, MCL 257.7a.
- 4 (b) "Behind-the-wheel instruction" means instruction in which
- 5 a student is in control of a motor vehicle on a public street or
- 6 highway in real and varied traffic situations and a driver
- 7 education instructor is the only other occupant in the front
- 8 passenger seating area with the student.
- 9 (c) "Classroom instruction" means that part of a driver
- 10 education course that occurs in a classroom environment that
- 11 enables a student to learn through varied instructional methods,
- 12 under the direct guidance of a driver education instructor.
- 13 (d) "Conviction" means a conviction for a crime or attempted
- 14 crime whether under a law of this state, a local ordinance
- 15 substantially corresponding to a law of this state, or a law of
- 16 another state substantially corresponding to a law of this state.
- 17 (e) "Coordinated segment 1 driver education course" means a
- 18 segment 1 course provided by 2 or more certified driver education
- 19 providers in the use of auxiliary aids and services as that term is
- 20 defined in the Americans with disabilities act of 1990, 42 USCA
- **21** 12102.
- 22 (f) "Curriculum" means a written plan that guides the
- 23 instruction given in a driver education course and includes
- 24 performance objectives, a content outline, detailed learning
- 25 activities, and assessment tools.
- 26 (g) "Designated representative or coordinator" means the
- 27 individual that a driver education provider employs, enlists, or

- 1 appoints, or contracts with to supervise, manage, and administer
- 2 the day-to-day responsibilities of the provider's driver education
- 3 school operation. Often this individual is an owner, partner,
- 4 officer, or director of the driver education provider.
- 5 (h) "Driver education course" means a program of study offered
- 6 by a certified driver education provider, which enables a student
- 7 to acquire the basic knowledge, skill, and attitude necessary to
- 8 operate a motor vehicle upon a highway transportation system.
- 9 (i) "Driver education course certificate of completion" means
- 10 a written or electronic authorization issued by a certified driver
- 11 education provider to a student who has successfully completed
- 12 segment 1 or segment 2 of a driver education course offered by the
- 13 provider.
- 14 (j) "Driver education instructor" means a person who the
- 15 secretary of state certifies has met the instructor qualifications
- 16 of this act to instruct a student in a driver education course.
- 17 (k) "Driver education instructor certificate" means a written
- 18 or electronic authorization issued by the secretary of state to
- 19 indicate that a person has met the instructor qualifications of
- 20 this act to instruct a student in a driver education course.
- 21 Sec. 5. As used in this act:
- (a) "Driver education instructor preparation program" means a
- 23 program of driver education instructor preparation courses offered
- 24 by a college or university or by a person required to be approved
- 25 by the secretary of state.
- 26 (b) Except as otherwise provided in this act, "driver
- 27 education instructor preparation courses" means the courses that

- 1 are required to obtain a driver education instructor certificate.
- 2 (c) "Driver education provider" or "provider" means a person
- 3 who meets the requirements in subparagraph (i), if not excluded
- 4 under subparagraph (ii), as follows:
- **5** (i) Gives instruction in the driving of a motor vehicle or
- 6 prepares an applicant for an exam given by the secretary of state
- 7 for a license as defined in section 25 of the Michigan vehicle
- 8 code, 1949 PA 300, MCL 257.25, or a vehicle indorsement issued
- 9 under former section 312e of the Michigan vehicle code, 1949 PA
- **10** 300.
- 11 (ii) Driver education provider does not include a person who
- 12 provides instruction as follows:
- 13 (A) Only for the benefit of its employees if that instruction
- 14 is not open to the public.
- 15 (B) In the driving or operating of a motorcycle as defined in
- 16 section 31 of the Michigan vehicle code, 1949 PA 300, MCL 257.31,
- 17 or the preparing of an applicant for an exam given by the secretary
- 18 of state for a motorcycle indorsement issued under section 312a of
- 19 the Michigan vehicle code, 1949 PA 300, MCL 257.312a.
- 20 (C) On an unpaid, casual basis to a relative or friend.
- 21 (d) "Driver education provider certificate" means a written or
- 22 electronic authorization issued by the secretary of state to
- 23 indicate that a person has met the driver education provider
- 24 qualifications of this act.
- (e) "Educational institution" means a public school, nonpublic
- 26 school, or public school academy as those terms are defined in
- 27 section 5 of the revised school code, 1976 PA 451, MCL 380.5; a

- 1 consortium that is defined to mean a partnership, association, or
- 2 alliance of 2 or more school districts in a common venture; a
- 3 community college, a 4-year college, a university, or any other
- 4 body of higher education.
- 5 (f) "Established office location" means a building that meets
- 6 all of the following requirements:
- 7 (i) Is of a permanent nature where the provider's
- 8 communications and notices are received.
- 9 (ii) Is heated, lighted, and ventilated and contains
- 10 appropriate space to properly store and preserve the information,
- 11 records, or other documents required to be maintained under this
- **12** act.
- (iii) Complies with applicable zoning and municipal
- 14 requirements.
- 15 (g) "Governmental agency" means an agency of the federal
- 16 government, a state government, a county, city, village, or
- 17 township, or a combination of any of these entities.
- 18 (h) "Graduated driver license" means a license issued by the
- 19 secretary of state under section 310e of the Michigan vehicle code,
- 20 1949 PA 300, MCL 257.310e.
- 21 (i) "Multiple vehicle driving facility" means that part of a
- 22 driver education course that enables the driver education
- 23 instructor, from a position outside the vehicle, and using
- 24 electronic or oral communication, to teach and supervise several
- 25 students simultaneously, each of whom is operating a vehicle at an
- 26 off-street facility specifically designed for that type of
- 27 instruction.

- 1 Sec. 7. As used in this act:
- 2 (a) "Performance objective" means a certain level of knowledge
- 3 and skill a student is expected to acquire to successfully complete
- 4 a driver education course.
- 5 (b) "Person" means an individual, partnership, corporation,
- 6 association, limited liability company, educational institution,
- 7 governmental agency or other legal or commercial entity, and their
- 8 legal successors.
- 9 (c) "Practicum" means classroom and behind-the-wheel
- 10 instruction in a driver education course under the direction of an
- 11 instructor employed, enlisted, or appointed by a college or
- 12 university or by a person approved by the secretary of state and a
- 13 cooperating instructor, providing practical application of theory
- 14 and experience for a student in an approved driver education
- 15 instructor preparation program. As used in this subdivision,
- "cooperating instructor" means a driver education instructor
- 17 approved by the secretary of state to participate in a practicum
- 18 course to mentor an uncertified driver education instructor in the
- 19 practicum.
- 20 (d) "Professional development requirements" means training
- 21 prescribed by the secretary of state to update the instructional
- 22 knowledge and skill of a driver education instructor.
- (e) "Revocation" means the termination of a driver education
- 24 provider's certification or a driver education instructor's
- 25 certification.
- 26 (f) "Segment 1" means a teen driver education course that
- 27 meets the requirements in section 37 of this act.

- 1 (g) "Segment 2" means a teen driver education course that
- 2 meets the requirements in section 39 of this act.
- 3 (h) "Simulator device training" means that part of a driver
- 4 education course where a driver education instructor uses
- 5 interactive simulator units and programs to reproduce driving
- 6 situations likely to occur in actual driving on a street and the
- 7 student is required to evaluate risk, make decisions, and respond
- 8 to the situations presented.
- 9 (i) "Suspension" means the temporary withdrawal of a person's
- 10 certification to engage or offer to engage in activities as a
- 11 driver education provider or a driver education instructor during
- 12 the period of suspension.
- 13 (j) "Teen driver training" means driver training instruction
- 14 provided through a segment 1 or segment 2 driver education course
- 15 that allows a person 17 years of age or less to apply for a level 1
- 16 or level 2 graduated driver license.
- 17 (k) "Truck driver training" means instruction that is provided
- 18 to operate a commercial motor vehicle as that term is defined in
- 19 section 7a of the Michigan vehicle code, 1949 PA 300, MCL 257.7a.
- 20 Sec. 9. (1) A person may apply to the secretary of state for a
- 21 driver education provider certificate in 1 or more of the following
- 22 classifications:
- 23 (a) Adult driver training.
- 24 (b) Teen driver training.
- 25 (c) Truck driver training.
- 26 (2) The secretary of state shall not grant an original driver
- 27 education provider certificate under this act until an

- 1 investigation is made of the applicant's qualification.
- 2 (3) Except as provided in this act, an applicant must do or
- 3 submit evidence that he or she has done or will do, as applicable,
- 4 all of the following to be eligible to receive a driver education
- 5 provider certificate:
- 6 (a) Submit a properly completed application signed by the
- 7 applicant.
- 8 (b) Maintain an established office location.
- 9 (c) Maintain classroom facilities in a public or commercial
- 10 setting.
- 11 (d) Maintain the surety bond required under this section.
- 12 (e) Require each of their designated representatives or
- 13 coordinators to complete a criminal history check as described in
- **14** section 29.
- 15 (f) Provide the name and address of each designated
- 16 representative or coordinator of the applicant, if applicable.
- 17 (g) Provide the name, address, date of birth, and social
- 18 security number of each owner or partner and, if a corporation, of
- 19 each of the principal officers.
- 20 (h) Provide a statement of the previous history, record, and
- 21 associations of the applicant and of each owner, partner, officer,
- 22 director, and designated representative or coordinator. The
- 23 statement shall be sufficient to establish to the satisfaction of
- 24 the secretary of state the business reputation and character of the
- 25 applicant.
- (i) Provide a statement indicating whether the applicant or
- 27 its designated representative or coordinator has ever applied for a

- 1 driver education provider certificate in this state or any other
- 2 state, and the result of that application.
- 3 (j) Provide a statement indicating whether the applicant or
- 4 its designated representative or coordinator has ever been denied a
- 5 driver education provider certificate or has ever been the holder
- 6 of a certificate that was suspended or revoked.
- 7 (k) If the applicant is a corporation or partnership, provide
- 8 a statement indicating whether a partner, employee, officer,
- 9 director, or its designated representative or coordinator has ever
- 10 been denied a driver education provider certificate or has ever
- 11 been the holder of a certificate that was suspended or revoked.
- (l) Certify that the applicant or another person named on the
- 13 application is not acting as the alter ego of any other person or
- 14 persons in seeking the certificate. For the purpose of this
- 15 subdivision, "alter ego" means a person who acts for and on behalf
- 16 of, or in the place of, another person for purposes of obtaining a
- 17 driver education provider certificate.
- 18 (m) Affirm that the established office location meets all
- 19 applicable zoning and municipal requirements.
- 20 (n) Obtain written or electronic verification from the state
- 21 fire marshal or his or her representative that the proposed
- 22 classroom facilities have been inspected and approved by the state
- 23 fire marshal or his or her representative according to state and
- 24 local building code and public occupancy requirements.
- 25 (o) Obtain written or electronic verification from an insurer
- 26 that the applicant maintains or will maintain bodily injury and
- 27 property damage liability insurance on each motor vehicle used in a

- 1 driver education course.
- 2 (p) Except as otherwise provided in this subdivision, submit a
- 3 nonrefundable application processing fee with the application as
- 4 follows:
- (i) \$225.00 for a driver education provider who offers adult or
- 6 teen driver training.
- 7 (ii) \$360.00 for a driver education provider who offers truck
- 8 driver training.
- 9 (iii) A fee is not required for an additional location that is
- 10 used for the sole purpose of conducting classroom instruction and
- 11 at which records are not maintained, enrollments are not made, and
- 12 staff is not ordinarily assigned, except for the purpose of
- 13 conducting classroom instruction.
- 14 (q) Provide a statement indicating whether the applicant will
- 15 use a multiple vehicle driving facility in a driver education
- 16 course. If a facility will be used, both of the following apply:
- 17 (i) The statement shall include a detailed description of the
- 18 facility as determined necessary by the secretary of state and its
- 19 address.
- 20 (ii) A multiple vehicle driving facility review and approval
- 21 fee of \$125.00 shall accompany the applicant's application for a
- 22 driver education provider certificate.
- 23 (r) Provide other information and documents as prescribed by
- 24 the secretary of state necessary to determine whether the applicant
- 25 meets the requirements of this act.
- 26 (4) An application for an original driver education provider
- 27 certificate shall include a properly executed surety bond or

- 1 renewal certificate with the application. If a renewal certificate
- 2 is used, the bond is considered renewed for each succeeding year in
- 3 the same amount and with the same effect as an original bond. The
- 4 bond or certificate shall be maintained continuously without
- 5 interruption to protect the contractual rights of students. The
- 6 bond or certificate of an adult or teen driver education provider
- 7 with 999 or fewer students in a calendar year shall be in the
- 8 principal sum of \$20,000.00 with good and sufficient surety to be
- 9 approved by the secretary of state. The bond or certificate of an
- 10 adult or teen driver education provider with 1,000 or more students
- in a calendar year shall be in the principal sum of \$40,000.00 with
- 12 good and sufficient surety to be approved by the secretary of
- 13 state. The bond or certificate of a truck driver education provider
- 14 shall be in the principal sum of \$50,000.00 with good and
- 15 sufficient surety to be approved by the secretary of state. The
- 16 bond shall indemnify or reimburse a student, financing agency, or
- 17 governmental agency for monetary loss caused through fraud,
- 18 cheating, or misrepresentation in the conduct of the driver
- 19 education provider's business where the fraud, cheating, or
- 20 misrepresentation was made by the provider or by an employee,
- 21 agent, instructor, or salesperson of the provider. The surety shall
- 22 make indemnification or reimbursement for a monetary loss only
- 23 after judgment based on fraud, cheating, or misrepresentation has
- 24 been entered in a court of record against the provider. The
- 25 aggregate liability of the surety shall not exceed the sum of the
- 26 bond. The surety on the bond may cancel the bond by giving 30 days'
- 27 written or electronic notice to the secretary of state and after

- 1 giving notice is not liable for a breach of condition occurring
- 2 after the effective date of the cancellation.
- 3 (5) A driver education provider who offers adult driver
- 4 training, teen driver training, and truck driver training shall
- 5 furnish a separate bond for each driver education provider
- 6 certificate issued by the secretary of state to the applicant. When
- 7 the secretary of state receives written or electronic notice that a
- 8 driver education provider's surety bond required under subsection
- 9 (4) or insurance coverage required under subsection (10) has been
- 10 canceled, the secretary of state shall notify the provider that the
- 11 provider's certificate shall be automatically canceled unless the
- 12 secretary of state receives a new surety bond or a new insurance
- 13 certificate within 30 days or less. If the provider fails to submit
- 14 a new surety bond or insurance certificate to the secretary of
- 15 state within 30 days or less, the secretary of state may
- 16 automatically cancel the provider's certificate. A driver education
- 17 provider who changes or terminates the provider's surety bond or
- 18 the insurance coverage before the expiration date of the bond or
- 19 insurance coverage shall immediately furnish the secretary of state
- 20 with written or electronic notice as prescribed by the secretary of
- 21 state of that change or termination and proof of a new bond or
- 22 insurance coverage.
- 23 (6) As a condition precedent to the granting of a certificate,
- 24 an applicant shall file with the secretary of state, on a form
- 25 prescribed by the secretary of state, an irrevocable written or
- 26 electronic stipulation. The stipulation shall be signed by the
- 27 applicant and state that the applicant agrees that legal process

- 1 affecting the applicant, served on the secretary of state against
- 2 the applicant or the applicant's successor in interest for a
- 3 violation of this act, a rule promulgated under this act, or an
- 4 order issued under this act, has the same effect as if personally
- 5 served on the applicant. This appointment remains in force as long
- 6 as the provider has any outstanding liability within this state
- 7 under this act.
- 8 (7) Subsections (3)(d) and (g) and (4) do not apply to an
- 9 educational institution or a governmental agency.
- 10 (8) Subsection (3)(c) does not apply to a classroom location
- 11 currently in use that was approved by the secretary of state in
- 12 writing before the effective date of this act.
- 13 (9) A classroom facility may not be located in a person's
- 14 residence or a structure attached or adjacent to the person's
- 15 residence unless the classroom facility was used and approved by
- 16 the secretary of state in writing before the effective date of this
- **17** act.
- 18 (10) A driver education provider shall maintain bodily injury
- 19 and property damage liability insurance on a motor vehicle used in
- 20 driver education course instruction. The insurance shall insure the
- 21 liability of the driver education provider, the driver education
- 22 instructors, and a person taking instruction in the amount of
- 23 \$100,000.00 for bodily injury to or the death of 1 person in 1
- 24 accident, and, subject to the limit for 1 person; \$300,000.00 for
- 25 bodily injury to or the death of 2 or more persons in 1 accident;
- and \$50,000.00 for damage to the property of others in 1 accident.
- 27 The insurer shall be authorized to do insurance business in this

- 1 state. The insurer shall not cancel the insurance before its
- 2 expiration date unless it gives the secretary of state written or
- 3 electronic notice as prescribed by the secretary of state of the
- 4 insurer's intent to cancel the insurance at least 30 days before
- 5 the cancellation.
- 6 (11) The secretary of state shall review and, in writing,
- 7 approve or deny the use of a multiple vehicle driving facility
- 8 under this act as determined necessary by the secretary of state.
- 9 The secretary of state shall approve a facility only if it meets
- 10 criteria prescribed by the secretary of state. The secretary of
- 11 state shall perform an on-site inspection of a multiple vehicle
- 12 driving facility as determined necessary by the secretary of state.
- 13 (12) The secretary of state may develop and prescribe an
- 14 orientation and education program that a person must complete
- 15 before the secretary of state issues that person an original driver
- 16 education provider certificate under section 13.
- 17 (13) Nonrefundable application processing and multiple vehicle
- 18 driving facility review and approval fees collected under this
- 19 section shall be deposited into the driver education provider and
- 20 instructor fund created in section 83.
- 21 Sec. 11. (1) A certified driver education provider may apply
- 22 for the renewal of a driver education provider certificate. The
- 23 renewal application shall be submitted to the secretary of state
- 24 every other year in a format and as prescribed by the secretary of
- 25 state. A renewal application shall include all of the following:
- 26 (a) A properly completed application signed by the applicant.
- 27 (b) A nonrefundable application processing fee as follows:

- $\mathbf{1}$ (i) \$225.00 for a driver education provider who offers adult or
- 2 teen driver training.
- 3 (ii) \$360.00 for a driver education provider who offers truck
- 4 driver training.
- 5 (c) If applicable, either of the following:
- 6 (i) A certification that the applicant has used a multiple
- 7 vehicle driving facility in a driver education course and that the
- 8 facility has not been altered or changed since the secretary of
- 9 state inspected that facility after the effective date of this act.
- 10 A nonrefundable multiple vehicle driving facility review and
- 11 approval fee of \$75.00 shall accompany the applicant's application
- 12 for a renewal of its driver education provider certificate.
- 13 (ii) A statement that the applicant will use a multiple vehicle
- 14 driving facility in a driver education course, a detailed
- 15 description of the facility as determined necessary by the
- 16 secretary of state, and its address. A multiple vehicle driving
- 17 facility review and approval fee of \$125.00 shall accompany the
- 18 applicant's application for a renewal of its driver education
- 19 provider certificate.
- 20 (d) Other information and documents prescribed by the
- 21 secretary of state as needed to determine whether the applicant
- 22 meets the requirements of this act.
- 23 (2) The designated representative or coordinator of a
- 24 certified driver education provider shall complete a criminal
- 25 history check as described in section 29 to the satisfaction of the
- 26 secretary of state every 4 years on an application to renew the
- 27 driver education provider's certificate.

- 1 (3) If the secretary of state receives a properly completed
- 2 renewal application before the applicant's driver education
- 3 provider's current certificate expires, the certificate continues
- 4 in full force and effect until the secretary of state either
- 5 approves or denies the renewal application. If the secretary of
- 6 state does not receive a properly completed renewal application
- 7 before the driver education provider certificate expires, the
- 8 driver education provider shall not offer to engage or engage in
- 9 the activity of a driver education provider until the secretary of
- 10 state issues the holder of the expired certificate an original or
- 11 renewal driver education provider certificate as provided in this
- **12** act.
- 13 (4) The secretary of state shall not issue a renewal
- 14 certificate more than 30 days after a driver education provider
- 15 certificate expires unless the provider has submitted a properly
- 16 completed renewal application within 30 days after the
- 17 certificate's expiration date. A provider that applies for a
- 18 certificate renewal later than 30 days after the certificate
- 19 expires shall apply to the secretary of state for an original
- 20 driver education provider certificate.
- 21 (5) The secretary of state shall review and, in writing,
- 22 approve or deny the use of a multiple vehicle driving facility
- 23 under this act as determined necessary by the secretary of state.
- 24 The secretary of state may only approve a facility that meets
- 25 criteria prescribed by the secretary of state. The secretary of
- 26 state shall perform an on-site inspection of a multiple vehicle
- 27 driving facility as determined necessary by the secretary of state.

- 1 (6) Subsection (1) (b) does not apply to an educational
- 2 institution or a governmental agency.
- 3 (7) Nonrefundable application processing and multiple vehicle
- 4 driving facility review and approval fees collected under this
- 5 section shall be deposited into the driver education provider and
- 6 instructor fund created under section 83.
- 7 Sec. 13. (1) The secretary of state may issue an original or
- 8 renewal driver education provider certificate if the secretary of
- 9 state is satisfied the applicant meets the requirements for that
- 10 certificate under this act. The secretary of state may assign an
- 11 identifying number to a driver education provider and put that
- 12 number on the provider's certificate. The secretary of state may
- 13 indicate the adult, teen, or truck driver training classification
- 14 applicable on the driver education provider's certificate.
- 15 (2) A driver education provider certificate issued under this
- 16 act is valid for 2 years. The original expiration date is exactly 2
- 17 years from the date the secretary of state issues the provider an
- 18 original certificate. A provider's renewal certificate expires 2
- 19 years after its issuance on the same day and month that the
- 20 original certificate expired.
- 21 (3) A person licensed as a driver training school by the
- 22 secretary of state or who has been approved for segment 1 and
- 23 segment 2 driver education course performance objectives under
- 24 former 1974 PA 369, and has submitted a properly completed renewal
- 25 application under former 1974 PA 369, to the secretary of state
- 26 before October 1, 2006 may continue to engage in activity for which
- 27 the person was licensed or approved while the secretary of state

- 1 processes the renewal application. If the secretary of state
- 2 approves that application and issues a license under former 1974 PA
- 3 369, that license or approval shall expire on December 31, 2006. A
- 4 person licensed or approved under former 1974 PA 369 to engage in
- 5 the activity of a driver education provider must comply with this
- 6 act by October 1, 2007. If a person licensed or approved under
- 7 former 1974 PA 369 applies to the secretary of state to renew that
- 8 license or approval under this act, the secretary of state may
- 9 require the applicant to submit either an original or renewal
- 10 application as determined necessary by the secretary of state.
- 11 (4) A person shall not transfer or assign a driver education
- 12 provider certificate to another person, and any purported transfer
- 13 or assignment is not effective.
- 14 Sec. 15. (1) A driver education provider shall immediately
- 15 notify the secretary of state in a manner prescribed by the
- 16 secretary of state of a change in an owner, partner, officer,
- 17 director, or the designated representative or coordinator of the
- 18 provider. Immediately upon notifying the secretary of state, the
- 19 provider shall also submit a request to the department of state
- 20 police for a criminal history check as described in section 29 of
- 21 the changed owner, partner, officer, director, or the designated
- 22 representative or coordinator of the provider.
- 23 (2) A driver education provider shall immediately notify the
- 24 secretary of state in a manner prescribed by the secretary of state
- 25 of a change of address for the established office location or the
- 26 classroom facilities of the provider. The provider shall also
- 27 submit with that address change notification any information,

- 1 record, report, or other document prescribed by the secretary of
- 2 state or required under this act.
- 3 (3) A person who stops operating as a driver education
- 4 provider or no longer qualifies as a certified driver education
- 5 provider shall immediately in a format prescribed by the secretary
- 6 of state do all of the following:
- 7 (a) Return the certificate issued under section 13 to the
- 8 secretary of state.

- 20 (4) A person who fails to immediately comply with subsection
- 21 (3)(a), (b), or (c) is guilty of a misdemeanor punishable by
- 22 imprisonment for not more than 93 days or a fine of not more than
- 23 \$2,000.00, or both.
- Sec. 17. (1) A person may apply to the secretary of state for
- 25 a driver education instructor certificate in 1 or more of the
- 26 following classifications:
- 27 (a) Adult driver training.

- 1 (b) Teen driver training.
- 2 (c) Truck driver training.
- 3 (2) The secretary of state shall not issue an original driver
- 4 education instructor certificate under this act until an
- 5 investigation is made of the applicant's qualification under this

- 7 (3) The secretary of state may issue a person a driver

- 22 Sec. 77. The expiration or absence of a driver education
- 23 provider certificate or a driver education instructor certificate
- 24 does not prevent the secretary of state from proceeding with an
- 25 investigation, disciplinary proceeding, or other action authorized
- 26 by this act against a person, a driver education provider, or a
- 27 driver education instructor.

- 1 Sec. 79. A person shall not engage in or offer to engage in
- 2 activity as a driver education provider or a driver education
- 3 instructor unless the person holds a valid certificate under this
- 4 act. A person who violates this section is guilty of a misdemeanor
- 5 punishable by imprisonment for not more than 93 days or a fine of
- 6 not more than \$2,000.00, or both. In addition to any other remedies
- 7 provided by law, the secretary of state may impose an

- 23 deposit into the fund. The state treasurer shall direct the
- 24 investment of the fund. The state treasurer shall annually present
- 25 to the secretary of state an accounting of the amount of money in
- 26 the fund. Any unexpended and unencumbered money in the fund at the
- 27 close of a fiscal year shall remain in the fund and shall not lapse

- 2 (2) A nonrefundable application processing fee, a multiple

- 17 Enacting section 1. The driver training schools rules, R
- 18 388.351 to R 388.362, and the driver education rules, R 388.302 to
- 19 R 388.338, of the Michigan administrative code are rescinded.
- 20 Enacting section 2. This act takes effect October 1, 2006.
