HOUSE SUBSTITUTE FOR SENATE BILL NO. 291

(As amended December 19, 2008)

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 411u.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411U. (1) IF A PERSON WHO IS AN ASSOCIATE OR A MEMBER OF
- 2 A GANG COMMITS A FELONY OR ATTEMPTS TO COMMIT A FELONY AND THE
- 3 PERSON'S ASSOCIATION OR MEMBERSHIP IN THE GANG PROVIDES THE MOTIVE,
- 4 MEANS, OR OPPORTUNITY TO COMMIT THE FELONY, THE PERSON IS
- 5 GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 20
- 6 YEARS. AS USED IN THIS SECTION:
- 7 (A) "GANG" MEANS AN ONGOING ORGANIZATION, ASSOCIATION, OR
- 8 GROUP OF 5 OR MORE PEOPLE[, OTHER THAN A NONPROFIT ORGANIZATION,] THAT IDENTIFIES ITSELF BY ALL OF THE
- 9 FOLLOWING:

- 1 (i) A UNIFYING MARK, MANNER, PROTOCOL, OR METHOD OF EXPRESSING
- 2 MEMBERSHIP, INCLUDING A COMMON NAME, SIGN OR SYMBOL, MEANS OF
- 3 RECOGNITION, GEOGRAPHICAL OR TERRITORIAL SITES, OR BOUNDARY OR
- 4 LOCATION.
- 5 (ii) AN ESTABLISHED LEADERSHIP OR COMMAND STRUCTURE.
- 6 (iii) DEFINED MEMBERSHIP CRITERIA.
- 7 (B) "GANG MEMBER" OR "MEMBER OF A GANG" MEANS A PERSON WHO
- 8 BELONGS TO A GANG.
- 9 (2) A SENTENCE IMPOSED UNDER THIS SECTION IS IN ADDITION TO
- 10 THE SENTENCE IMPOSED FOR THE CONVICTION OF THE UNDERLYING FELONY OR
- 11 THE ATTEMPT TO COMMIT THE UNDERLYING FELONY AND MAY BE SERVED
- 12 CONSECUTIVELY WITH AND PRECEDING ANY TERM OF IMPRISONMENT IMPOSED
- 13 FOR THE CONVICTION OF THE FELONY OR ATTEMPT TO COMMIT THE FELONY.
