HOUSE SUBSTITUTE FOR SENATE BILL NO. 660

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 411v.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411V. (1) A PERSON SHALL NOT CAUSE, ENCOURAGE, RECRUIT,
- 2 SOLICIT, OR COERCE ANOTHER TO JOIN, PARTICIPATE IN, OR ASSIST A
- 3 GANG IN COMMITTING A FELONY. A PERSON WHO VIOLATES THIS SUBSECTION
- 4 IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN
- 5 YEARS OR A FINE OF NOT MORE THAN \$5,000.00, OR BOTH.
- 6 (2) A PERSON SHALL NOT COMMUNICATE, DIRECTLY OR INDIRECTLY, TO
- 7 ANOTHER PERSON A THREAT OF INJURY OR DAMAGE TO THE PERSON OR
- 8 PROPERTY OF THAT PERSON OR TO AN ASSOCIATE OR RELATIVE OF THAT
- 9 PERSON WITH THE INTENT TO DO EITHER OF THE FOLLOWING:
- 10 (A) DETER THE OTHER PERSON FROM ASSISTING A GANG MEMBER OR

- 1 ASSOCIATE OF A GANG TO WITHDRAW FROM THE GANG.
- 2 (B) PUNISH OR RETALIATE AGAINST THE OTHER PERSON FOR HAVING
- 3 WITHDRAWN FROM A GANG.
- 4 (3) A PERSON WHO VIOLATES SUBSECTION (2) IS GUILTY OF A FELONY
- 5 PUNISHABLE FOR NOT MORE THAN 20 YEARS OR A FINE OF NOT MORE THAN
- 6 \$20,000.00, OR BOTH.
- 7 (4) A SENTENCE IMPOSED UNDER THIS SECTION IS IN ADDITION TO A
- 8 SENTENCE IMPOSED FOR THE CONVICTION OF ANOTHER FELONY OR ATTEMPT TO
- 9 COMMIT A FELONY ARISING OUT OF THE SAME TRANSACTION AND MAY BE
- 10 ORDERED TO BE SERVED CONSECUTIVELY WITH AND PRECEDING A TERM OF
- 11 IMPRISONMENT IMPOSED FOR THE CONVICTION OF THAT FELONY OR ATTEMPT
- 12 TO COMMIT THAT FELONY.
- 13 (5) AS USED IN THIS SECTION:
- 14 (A) "GANG" MEANS AN ONGOING ORGANIZATION, ASSOCIATION, OR
- 15 GROUP OF 5 OR MORE PEOPLE[, OTHER THAN A NONPROFIT ORGANIZATION,] THAT IDENTIFIES ITSELF BY ALL OF THE
- 16 FOLLOWING:
- 17 (i) A UNIFYING MARK, MANNER, PROTOCOL, OR METHOD OF EXPRESSING
- 18 MEMBERSHIP, INCLUDING A COMMON NAME, SIGN OR SYMBOL, MEANS OF
- 19 RECOGNITION, [GEOGRAPHICAL OR TERRITORIAL SITES, OR BOUNDARY OR
- 20 LOCATION.]
- 21 (ii) AN ESTABLISHED LEADERSHIP OR COMMAND STRUCTURE.
- 22 (iii) DEFINED MEMBERSHIP CRITERIA.
- 23 (B) "GANG MEMBER" MEANS A PERSON WHO BELONGS TO A GANG.
- 24 Enacting section 1. This amendatory act takes effect April 1,
- **25** 2009.
- 26 Enacting section 2. This amendatory act does not take effect
- 27 unless Senate Bill No. 661 of the 94th Legislature is enacted into
