## SENATE BILL NO. 749

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," (MCL 600.101 to 600.9947) by adding sections 3185 and 3285.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 3185. (1) IF A DEFENDANT IN AN ACTION TO FORECLOSE A 2 MORTGAGE ON REAL ESTATE OR A LAND CONTRACT IS A SERVICE MEMBER AND 3 EITHER THE DEFENDANT ENTERED INTO THE MORTGAGE OR LAND CONTRACT 4 BEFORE BECOMING A SERVICE MEMBER OR THE DEFENDANT IS DEPLOYED IN 5 OVERSEAS SERVICE, THE COURT ON ITS OWN MOTION MAY, OR ON MOTION OF 6 OR IN BEHALF OF THE SERVICE MEMBER SHALL, DO EITHER OR BOTH OF THE 7 FOLLOWING, UNLESS THE COURT DETERMINES THAT THE ABILITY OF THE 8 DEFENDANT TO COMPLY WITH THE TERMS OF THE OBLIGATION SECURED BY THE 9 MORTGAGE OR LAND CONTRACT IS NOT MATERIALLY AFFECTED BY THE SERVICE 10 MEMBER'S MILITARY SERVICE:

2 (B) ISSUE ANOTHER ORDER THAT IS EQUITABLE TO CONSERVE THE 3 INTERESTS OF THE PARTIES.

14 (B) "MILITARY SERVICE" MEANS ANY OF THE FOLLOWING:

15 (i) ACTIVE DUTY.

16 (*ii*) IF THE SERVICE MEMBER IS A MEMBER OF THE NATIONAL GUARD,
17 SERVICE UNDER A CALL TO ACTIVE SERVICE AUTHORIZED BY THE PRESIDENT
18 OR SECRETARY OF DEFENSE OF THE UNITED STATES FOR A PERIOD OF MORE
19 THAN 30 CONSECUTIVE DAYS UNDER 32 USC 502(F) TO RESPOND TO A
20 NATIONAL EMERGENCY DECLARED BY THE PRESIDENT AND SUPPORTED BY
21 FEDERAL MONEY.

22 (*iii*) A PERIOD DURING WHICH THE SERVICE MEMBER IS ABSENT FROM
23 ACTIVE DUTY BECAUSE OF SICKNESS, WOUNDS, LEAVE, OR OTHER LAWFUL
24 CAUSE.

(C) "PERIOD OF MILITARY SERVICE" MEANS THE PERIOD BEGINNING ON
THE DATE ON WHICH THE SERVICE MEMBER ENTERS MILITARY SERVICE AND
ENDING ON THE DATE ON WHICH THE SERVICE MEMBER IS RELEASED FROM

1 MILITARY SERVICE OR DIES WHILE IN MILITARY SERVICE.

2 (D) "SERVICE MEMBER" MEANS AN INDIVIDUAL WHO IS IN MILITARY 3 SERVICE AND IS A MEMBER OF THE ARMED SERVICES OR RESERVE FORCES OF 4 THE UNITED STATES OR A MEMBER OF THE MICHIGAN NATIONAL GUARD.

5 SEC. 3285. (1) IF A MORTGAGOR IS A SERVICE MEMBER, EITHER THE MORTGAGOR ENTERED INTO THE MORTGAGE BEFORE BECOMING A SERVICE 6 MEMBER OR THE MORTGAGOR IS DEPLOYED IN OVERSEAS SERVICE, AND, 7 DURING THE SERVICE MEMBER'S PERIOD OF MILITARY SERVICE OR WITHIN 6 8 MONTHS AFTER THE END OF THE PERIOD OF MILITARY SERVICE, THE 9 10 MORTGAGE GIVEN BY THE SERVICE MEMBER IS FORECLOSED BY ADVERTISEMENT OR THE MORTGAGED REAL ESTATE SOLD UNDER A POWER OF SALE, THE 11 12 FORECLOSURE OR SALE IS INVALID UNLESS THE FORECLOSURE OR SALE WAS 13 ORDERED BY A COURT.

14 (2) A PERSON SHALL NOT, INDIVIDUALLY OR ACTING THROUGH ANOTHER
15 PERSON, FORECLOSE, SELL, OR ATTEMPT TO FORECLOSE OR SELL REAL
16 ESTATE WITH THE KNOWLEDGE THAT THE FORECLOSURE OR SALE IS INVALID
17 UNDER THIS SECTION. A PERSON WHO VIOLATES THIS SUBSECTION IS
18 SUBJECT TO A CIVIL FINE OF \$2,000.00.

(3) THE ATTORNEY GENERAL MAY FILE AN ACTION IN THE CIRCUIT
 COURT TO COLLECT A CIVIL FINE UNDER THIS SECTION. A CIVIL FINE
 COLLECTED UNDER THIS SECTION SHALL BE DEPOSITED IN THE MILITARY
 FAMILY RELIEF FUND CREATED IN SECTION 3 OF THE MILITARY FAMILY
 RELIEF FUND ACT, 2004 PA 363, MCL 35.1213.

15 (iii) A PERIOD DURING WHICH THE SERVICE MEMBER IS ABSENT FROM ACTIVE DUTY BECAUSE OF SICKNESS, WOUNDS, LEAVE, OR OTHER LAWFUL 16 17 CAUSE.

(C) "PERIOD OF MILITARY SERVICE" MEANS THE PERIOD BEGINNING ON 18 19 THE DATE ON WHICH THE SERVICE MEMBER ENTERS MILITARY SERVICE AND 20 ENDING ON THE DATE ON WHICH THE SERVICE MEMBER IS RELEASED FROM MILITARY SERVICE OR DIES WHILE IN MILITARY SERVICE. 21

(D) "SERVICE MEMBER" MEANS AN INDIVIDUAL WHO IS IN MILITARY 22 SERVICE AND IS A MEMBER OF THE ARMED SERVICES OR RESERVE FORCES OF 23 24 THE UNITED STATES OR A MEMBER OF THE MICHIGAN NATIONAL GUARD.
