## SUBSTITUTE FOR SENATE BILL NO. 346

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 66.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 66. (1) IF A PERSON 18 YEARS OF AGE OR OLDER IS
- 2 RESPONSIBLE FOR CONTROLLING THE ACTIONS OF A DOG OR WOLF-DOG CROSS
- 3 AND THE PERSON KNOWS OR HAS REASON TO KNOW THAT THE DOG OR WOLF-DOG
- 4 CROSS HAS BITTEN ANY INDIVIDUAL, THE PERSON SHALL IMMEDIATELY
- 5 PROVIDE THE INDIVIDUAL WHO WAS BITTEN WITH ALL OF THE FOLLOWING
- 6 INFORMATION:
- 7 (A) HIS OR HER NAME AND ADDRESS AND, IF THAT PERSON DOES NOT
- 8 OWN THE DOG OR WOLF-DOG CROSS, THE NAME AND ADDRESS OF THE DOG'S OR
- 9 WOLF-DOG CROSS'S OWNER.
- 10 (B) INFORMATION, IF KNOWN BY THAT PERSON, AS TO WHETHER THE
- 11 DOG OR WOLF-DOG CROSS IS CURRENT ON ALL LEGALLY REQUIRED

- 1 VACCINATIONS.
- (2) IF A PERSON 18 YEARS OF AGE OR OLDER IS RESPONSIBLE FOR 2
- 3 CONTROLLING THE ACTIONS OF A DOG OR WOLF-DOG CROSS AND THE PERSON
- KNOWS OR HAS REASON TO KNOW THAT THE DOG OR WOLF-DOG CROSS HAS 4
- BITTEN ANY INDIVIDUAL, THE PERSON SHALL REMAIN ON THE SCENE UNTIL 5
- 6 THE REQUIREMENTS OF THIS SECTION ARE FULFILLED.
- 7 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
- MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 93 DAYS OR 8
- A FINE OF NOT MORE THAN \$500.00, OR BOTH.
- 10 (4) THIS SECTION DOES NOT APPLY IF THE PERSON IS BITTEN BY A
- POLICE DOG. AS USED IN THIS SUBSECTION, "POLICE DOG" MEANS THAT 11
- 12 TERM AS DEFINED IN SECTION 50C.
- (5) AS USED IN THIS SECTION, "DOG" AND "WOLF-DOG CROSS" MEAN 13
- 14 THOSE TERMS AS DEFINED IN SECTION 2 OF THE WOLF-DOG CROSS ACT, 2000
- 15 PA 246, MCL 287.1002.
- 16 Enacting section 1. This amendatory act takes effect April 1,
