A bill to amend 2004 PA 175, entitled "Streamlined sales and use tax revenue equalization act," (MCL 205.171 to 205.191) by adding section 10.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 10. (1) BEGINNING JUNE 1, 2007, A CREDIT EQUAL TO 6% OF
- 2 THE PRODUCT OF THE OUT-OF-STATE MILEAGE PERCENTAGE AND THE PRICE OF
- 3 A QUALIFIED TRUCK, A TRAILER DESIGNED TO BE DRAWN BEHIND A
- 4 QUALIFIED TRUCK, OR PARTS AFFIXED TO EITHER A QUALIFIED TRUCK OR A
- 5 TRAILER DESIGNED TO BE DRAWN BEHIND A QUALIFIED TRUCK, PURCHASED,
- 6 RENTED, LEASED, OR OTHERWISE USED IN THIS STATE, AND USED IN
- 7 INTERSTATE COMMERCE, MAY BE CLAIMED BY AN INTERSTATE FLEET MOTOR

- 21 OF 10,000 POUNDS OR A COMMERCIAL MOTOR VEHICLE POWER UNIT THAT HAS
- 22 3 OR MORE AXLES.
