A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 8635.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 8635. (1) SUBJECT TO SUBSECTION (2), A PERSON WHO HAS AN
- 2 INTEREST THAT IS OR MAY BE ADVERSELY AFFECTED MAY COMMENCE A CIVIL
- 3 ACTION ON HIS OR HER OWN BEHALF AGAINST EITHER OF THE FOLLOWING:
- 4 (A) A CAFO, FOR A VIOLATION OF THIS PART, PART 31, OR A RULE 5 PROMULGATED OR PERMIT ISSUED UNDER THIS PART OR PART 31.
  - (B) THE DEPARTMENT OR THE DEPARTMENT OF AGRICULTURE, FOR A FAILURE TO PERFORM ANY NONDISCRETIONARY ACT OR DUTY UNDER THIS PART.
  - (2) AN ACTION SHALL NOT BE COMMENCED UNDER SUBSECTION (1)
