THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 ARTICLE 16. IN-HOME MEDICAL CARE
2 PART 192. AUDITS

SEC. 19201. (1) THE DEPARTMENT SHALL PERFORM AN ANNUAL, RANDOM

4 AUDIT OF NOT LESS THAN 5% OF ALL HEALTH CARE PROVIDERS WHO PROVIDE

5 IN-HOME MEDICAL CARE SERVICES IN THIS STATE AND ARE REIMBURSED IN

6 WHOLE OR IN PART FOR THOSE SERVICES WITH STATE OR FEDERAL FUNDS.

(2) IF A HEALTH CARE PROVIDER DESCRIBED IN SUBSECTION (1)
PROVIDES MEDICAL CARE SERVICES OTHER THAN IN-HOME MEDICAL CARE
SERVICES, THE DEPARTMENT SHALL AUDIT ONLY THOSE MEDICAL CARE
