- 1 SEC. 601D. (1) A PERSON WHO COMMITS A MOVING VIOLATION AND AS
- 2 A RESULT CAUSES INJURY TO A VULNERABLE ROADWAY USER ON A HIGHWAY
- 3 WHO IS IN COMPLIANCE WITH THIS ACT IS GUILTY OF A MISDEMEANOR
- 4 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR A FINE OF
- 5 NOT MORE THAN \$1,000.00, OR BOTH.
- 6 (2) A PERSON WHO COMMITS A MOVING VIOLATION AND AS A RESULT
- 7 CAUSES DEATH TO A VULNERABLE ROADWAY USER ON A HIGHWAY WHO IS IN
- 8 COMPLIANCE WITH THIS ACT IS GUILTY OF A FELONY PUNISHABLE BY
- 9 IMPRISONMENT FOR NOT MORE THAN 15 YEARS OR A FINE OF NOT MORE THAN

- 25 (C) "VULNERABLE ROADWAY USER" MEANS A PEDESTRIAN OR A PERSON
- 26 OPERATING A NONMOTORIZED TRANSPORTATION DEVICE.
