HOUSE BILL No. 6446

September 11, 2008, Introduced by Rep. Condino and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled

"The code of criminal procedure,"

by amending section 11 of chapter II (MCL 762.11), as amended by 2004 PA 239.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 CHAPTER II

Sec. 11. (1) Except as provided in subsections (2) and (3), if an individual pleads guilty to a criminal offense, committed on or after the individual's seventeenth birthday but before his or her twenty-first birthday, the court of record having jurisdiction of the criminal offense may, without entering a judgment of conviction

and with the consent of that individual, consider and assign that

- 2 (2) Subsection (1) does not apply to any of the following:
- 3 (a) A felony for which the maximum penalty is imprisonment for
