SENATE BILL No. 45

January 24, 2007, Introduced by Senators CROPSEY and SCOTT and referred to the Committee on Judiciary.

A bill to amend 1972 PA 222, entitled

"An act to provide for an official personal identification card; to provide for its form, issuance and use; to regulate the use and disclosure of information obtained from the card; to prescribe the powers and duties of the secretary of state; to prescribe fees; to prescribe certain penalties for violations; and to provide an appropriation for certain purposes,"

by amending section 1 (MCL 28.291), as amended by 2005 PA 143.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) A person who is a resident of this state may apply
- 2 to the department of state for an official state personal
- 3 identification card. Upon application the applicant shall supply a
- 4 birth certificate attesting to his or her age or other sufficient
- 5 documents or identification as the secretary of state may require.
 - An application for a state personal identification card shall be

- 1 made in a manner prescribed by the secretary of state and shall
- 2 contain the applicant's full name, date of birth, residence
- 3 address, height, sex, eye color, signature, and, beginning January
- 4 1, 2007, intent to be an organ donor, and other information
- 5 required or permitted on the official state personal identification
- 6 card. The applicant may provide a mailing address if the applicant
- 7 receives mail at an address different from his or her residence
- 8 address.
- 9 (2) THE SECRETARY OF STATE SHALL ACCEPT AS 1 OF THE
- 10 IDENTIFICATION DOCUMENTS REQUIRED UNDER SUBSECTION (1) AN
- 11 IDENTIFICATION CARD ISSUED BY THE DEPARTMENT OF CORRECTIONS TO
- 12 PRISONERS WHO ARE PLACED ON PAROLE OR RELEASED FROM A CORRECTIONAL
- 13 FACILITY, CONTAINING THE PRISONER'S NAME, PHOTOGRAPH, AND OTHER
- 14 INFORMATION IDENTIFYING THE PRISONER AS PROVIDED IN SECTION 37(4)
- 15 OF THE CORRECTIONS CODE OF 1953, 1953 PA 232, MCL 791.237.
- 16 (3) THE SECRETARY OF STATE SHALL HAVE ELECTRONIC ACCESS TO
- 17 PRISONER BIOGRAPHY INFORMATION MAINTAINED BY THE DEPARTMENT OF
- 18 CORRECTIONS FOR THE PURPOSE OF VERIFYING THE IDENTITY OF A PRISONER
- 19 WHO APPLIES FOR AN OFFICIAL STATE IDENTIFICATION CARD UNDER
- 20 SUBSECTION (1).
- 21 (4) (2)—The secretary of state shall not issue an official
- 22 state personal identification card to a person who holds an
- 23 operator's or chauffeur's license issued under the Michigan vehicle
- 24 code, 1949 PA 300, MCL 257.1 to 257.923, unless the license has
- 25 been suspended, revoked, or restricted.
