THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 124. (1) This act does not modify the requirements of the
 following:
- 3 (a) The supervision of trustees for charitable purposes act,4 1961 PA 101, MCL 14.251 to 14.266.
- **5** (b) 1965 PA 169, MCL 450.251 to 450.253.
- (c) The charitable organizations and solicitations act, 1975

- 1 PA 169, MCL 400.271 to 400.294.
- 2 (d) The uniform PRUDENT management of institutional funds act.
- 3 , 1976 PA 157, MCL 450.1201 to 450.1210.
- 4 (e) The career development and distance learning act, 2002 PA
- 5 36, MCL 390.1571 TO 390.1579.
- 6 (2) A corporation subject to any 1 or more of the acts listed
- 7 in subsection (1) shall comply with those acts and shall comply
- 8 with this act. If there is any inconsistency between those acts and
- 9 this act, those acts shall control.
- 10 Sec. 261. (1) A corporation, subject to any limitation
- 11 provided in this act, in any other statute of this state, in its
- 12 articles of incorporation, or otherwise by law, shall have power
- 13 MAY in furtherance of its corporate purposes to DO ANY OF THE
- 14 FOLLOWING:
- 15 (a) Have perpetual duration.
- 16 (b) Sue and be sued in all courts and participate in actions
- 17 and proceedings judicial, administrative, arbitrative, or
- 18 otherwise, in like cases as THE SAME MANNER AS A natural persons
- 19 PERSON.
- 20 (c) Have a corporate seal, and alter the seal, and use it by
- 21 causing it or a facsimile to be affixed, impressed, or reproduced
- in any other manner.
- 23 (d) Adopt, amend, or repeal bylaws, including emergency
- 24 bylaws, relating to the purposes of the corporation, the conduct of
- 25 its affairs, its rights and powers, and the rights and powers of
- 26 its shareholders, members, directors, or officers.
- (e) Elect or appoint officers, employees, and other agents of

- 1 the corporation, prescribe their duties, fix their compensation and
- 2 the compensation of directors, and indemnify corporate directors,
- 3 officers, employees, and agents.
- 4 (f) Purchase, receive, take by grant, gift, devise, bequest,
- 5 or otherwise, lease, or otherwise acquire, own, hold, improve,
- 6 employ, use, and otherwise deal in and with, real or personal
- 7 property, or an interest therein IN REAL OR PERSONAL PROPERTY,
- 8 wherever situated, either absolutely or in trust and without
- 9 limitation as to amount or value.
- 10 (g) Sell, convey, lease, exchange, transfer, or otherwise
- 11 dispose of, or mortgage or pledge, or create a security interest
- 12 in, any of its property, or an interest therein IN THE PROPERTY,
- 13 wherever situated.
- 14 (h) Purchase, take, receive, subscribe for, or otherwise
- 15 acquire, own, hold, vote, employ, sell, lend, lease, exchange,
- 16 transfer, or otherwise dispose of, mortgage, pledge, use, and
- 17 otherwise deal in and with, bonds and other obligations, shares or
- 18 other securities or interests or memberships issued by others,
- 19 whether engaged in similar or different business, governmental, or
- 20 other activities, including banking corporations or trust
- 21 companies. A corporation organized or conducting affairs in this
- 22 state under this act may SHALL not guarantee or become surety upon
- 23 a bond or other undertaking securing the deposit of public money.
- 24 (i) Make contracts, give guarantees, and incur liabilities,
- 25 borrow money at such rates of interest as the corporation may
- 26 determine, issue its notes, bonds, and other obligations, and
- 27 secure any of its obligations by mortgage or pledge of any of its

- 1 property or an interest therein IN THE PROPERTY, wherever situated.
- 2 (j) Lend money, invest and reinvest its funds, and take and
- 3 hold real and personal property as security for the payment of
- 4 funds loaned or invested.
- 5 (k) Make donations for public welfare or for community fund,
- 6 hospital, charitable, educational, scientific, civic, or similar
- 7 purposes, and in time of war or other national emergency in aid
- 8 thereof OF WAR OR OTHER NATIONAL EMERGENCY.
- 9 (1) Pay pensions, establish and carry out pension, savings,
- 10 thrift, and other retirement, incentive, and benefit plans, trusts
- 11 and provisions for any of its directors, officers, and employees.
- 12 (m) Purchase, receive, take, otherwise acquire, own, hold,
- 13 sell, lend, exchange, transfer, otherwise dispose of, pledge, use,
- 14 and otherwise deal in and with its own shares, bonds, and other
- 15 securities.
- 16 (n) Participate with others in any corporation, business
- 17 corporation, partnership, limited partnership, joint venture, or
- 18 other association of any kind, or participate with others in any
- 19 transaction, undertaking, or agreement which THAT the participating
- 20 corporation would have power to conduct by itself, whether or not
- 21 the participation involves sharing or delegation of control with or
- 22 to others.
- (o) Cease its corporate activities and dissolve.
- 24 (p) Conduct its affairs, carry on its operations, and have
- 25 offices and exercise the powers granted by this act in any
- 26 jurisdiction within or without the United States, and, in the case
- 27 of a corporation the purpose or purposes of which require the

- 1 transaction of business, the receipt and payment of money, the care
- 2 and custody of property, and other incidental business matters,
- 3 transact such business, receive, collect, and disburse such money,
- 4 and engage in such other incidental business matters as are
- 5 naturally or properly within the scope of its articles.
- (q) Have and exercise all powers necessary or convenient to
- 7 effect any purpose for which the corporation is formed.
- 8 (2) A corporation subject to Act No. 157 of the Public Acts of
- 9 1976, being sections 451.1201 to 451.1210 of the Michigan Compiled
- 10 Laws, shall have THE UNIFORM PRUDENT MANAGEMENT OF INSTITUTIONAL
- 11 FUNDS ACT HAS all powers granted under BOTH this act and Act No.
- 12 157 of the Public Acts of 1976 THAT ACT. However, in the event of
- 13 an inconsistency between this act and Act No. 157 of the Public
- 14 Acts of 1976, Act No. 157 shall control THE 2 ACTS, THE UNIFORM
- 15 PRUDENT MANAGEMENT OF INSTITUTIONAL FUNDS ACT CONTROLS.
- 16 (3) The corporate existence of all corporations incorporated
- 17 before the effective date of this act JANUARY 1, 1983, without
- 18 capital stock, for religious, benevolent, social, or fraternal
- 19 purposes, shall be deemed CONSIDERED to be in perpetuity. A
- 20 limitation or term fixed in the articles or in the law under which
- 21 the corporation originally incorporated shall not be IS NOT
- 22 effective unless the corporation has—affirmatively waived its right
- 23 to perpetual existence subsequent to AFTER September 18, 1931, by
- 24 fixing a definite term of existence by amendment to its articles.
- 25 (4) Any nonprofit power corporation which THAT is authorized
- 26 to furnish electric service may construct, maintain, and operate
- 27 its lines along, over, across, or under any public places, streets,

- 1 and highways, and across or under the waters in this state, with
- 2 all necessary erections and fixtures. A nonprofit power corporation
- 3 may exercise the power of eminent domain, in the manner provided by
- 4 Act No. 87 of the Public Acts of 1980, as amended, being sections
- 5 213.51 to 213.77 of the Michigan Compiled Laws THE UNIFORM
- 6 CONDEMNATION PROCEDURES ACT, 1980 PA 87, MCL 213.51 TO 213.75. As a
- 7 condition to the exercise of any of these powers, nonprofit
- 8 corporations shall be ARE subject to the jurisdiction of the
- 9 Michigan public service commission pursuant to Act No. 106 of the
- 10 Public Acts of 1909, as amended, being sections 460.551 to 460.559
- 11 of the Michigan Compiled Laws 1909 PA 106, MCL 460.551 TO 460.559,
- 12 Act No. 419 of the Public Acts of 1919, as amended, being sections
- 13 460.51 to 460.62 of the Michigan Compiled Laws 1919 PA 419, MCL
- 14 460.54 TO 460.62, and Act No. 3 of the Public Acts of 1939, as
- 15 amended, being sections 460.1 to 460.8 of the Michigan Compiled
- 16 Laws 1939 PA 3, MCL 460.1 TO 460.10CC.
- Sec. 501. (1) The business and affairs of a corporation shall
- 18 be managed by its board, except as otherwise provided in this act.
- 19 A director need not be a shareholder or member of the corporation
- 20 unless the articles or bylaws so require. The articles or bylaws
- 21 may prescribe qualifications for directors.
- 22 (2) The board of a corporation which THAT is subject to Act
- No. 157 of the Public Acts of 1976, being sections 451.1201 to
- 24 451.1210 of the Michigan Compiled Laws, shall have THE UNIFORM
- 25 PRUDENT MANAGEMENT OF INSTITUTIONAL FUNDS ACT HAS the powers
- 26 granted under Act No. 157 of the Public Acts of 1976 BOTH THAT ACT
- 27 and this act. However, in the event of an inconsistency between

- 1 this act and Act No. 157 of the Public Acts of 1976, Act No. 157
- 2 shall control THE 2 ACTS, THE UNIFORM PRUDENT MANAGEMENT OF
- 3 INSTITUTIONAL FUNDS ACT CONTROLS.
- 4 Sec. 541. (1) A director or an officer shall discharge the
- 5 duties of that position in good faith and with that THE degree of
- 6 diligence, care, and skill which THAT an ordinarily prudent person
- 7 would exercise under similar circumstances in a like position. In
- 8 discharging the duties, a director or an officer, when acting in
- 9 good faith, may rely upon the opinion of counsel for the
- 10 corporation, upon the report of an independent appraiser selected
- 11 with reasonable care by the board, or upon financial statements of
- 12 the corporation represented to the director or officer as correct
- 13 by the president or the officer of the corporation having WHO HAS
- 14 charge of its books or account, or as stated in a written report by
- 15 an independent public or certified public accountant or firm of
- 16 accountants fairly to reflect the financial condition of the
- 17 corporation.
- 18 (2) A director or officer of a corporation subject to the
- 19 uniform PRUDENT management of institutional funds act, Act No. 157
- of the Public Acts of 1976, being sections 451.1201 to 451.1210 of
- 21 the Michigan Compiled Laws, shall be considered TO BE in compliance
- 22 with this section when IF the director or officer complies with
- 23 section 7 of Act No. 157 of the Public Acts of 1976 SECTION 5 OF
- 24 THE UNIFORM PRUDENT MANAGEMENT OF INSTITUTIONAL FUNDS ACT in the
- 25 administration of the powers specified in that section.
- 26 (3) If the corporation's articles of incorporation contain a
- 27 provision authorized under section 209(c), then—a volunteer

- 1 director of the corporation shall—IS only be—personally liable for
- 2 monetary damages for a breach of fiduciary duty as a director to
- 3 the corporation, its shareholders, or its members to the extent set
- 4 forth in the provision.
- 5 (4) If the corporation's articles of incorporation contain a
- 6 provision authorized under section 209(d), then a claim for
- 7 monetary damages for a breach of a volunteer director's duty to any
- 8 person other than the corporation, its shareholders, or its members
- 9 shall not be brought or maintained against a THE volunteer
- 10 director. Such a THE claim shall be brought or maintained instead
- 11 against the corporation, which corporation shall be liable for the
- 12 ANY breach of the volunteer director's duty.
- 13 (5) An action against a director or officer for failure to
- 14 perform the duties imposed by this section shall be commenced
- 15 within 3 years after the cause of action has accrued, or within 2
- 16 years after the time when the cause of action is discovered, or
- 17 should reasonably have been discovered, by the complainant,
- 18 whichever occurs first.
- 19 Enacting section 1. This amendatory act does not take effect
- 20 unless Senate Bill No. 392
- of the 94th Legislature is enacted into law.
