## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 473A. (1) BEFORE THE SUPPORTERS OF A BALLOT QUESTION
- 2 PETITION PROPOSING A CONSTITUTIONAL AMENDMENT, INITIATION OF
- 3 LEGISLATION, OR REFERENDUM OF LEGISLATION CIRCULATE THE BALLOT
- 4 QUESTION PETITION FOR SIGNATURES, THE SUPPORTERS OF THE BALLOT
- 5 QUESTION PETITION SHALL SUBMIT THE PROPOSED BALLOT QUESTION
- 6 PETITION TO THE SECRETARY OF STATE.
- 7 (2) UPON RECEIPT OF THE PROPOSED BALLOT QUESTION PETITION, THE
- 8 SECRETARY OF STATE SHALL FORWARD THE PROPOSED BALLOT QUESTION
  - PETITION TO THE BOARD OF STATE CANVASSERS.

- 12 SUBSECTION (3), THE PROPOSED BALLOT QUESTION PETITION IS CONSIDERED
- 13 APPROVED AS SUBMITTED.
- 14 (5) IF THE BOARD OF STATE CANVASSERS DENIES THE PROPOSED
- 15 BALLOT QUESTION PETITION, THE BOARD OF STATE CANVASSERS SHALL
- 16 NOTIFY THE SUPPORTERS OF THE BALLOT QUESTION PETITION OF THE DENIAL
- 17 AND THE REASON FOR THE DENIAL. THIS SUBSECTION DOES NOT PROHIBIT A
- 18 PERSON FROM RESUBMITTING A PROPOSED BALLOT QUESTION PETITION TO THE
- 19 BOARD OF STATE CANVASSERS FOR REVIEW AND APPROVAL UNDER THIS
- 20 SECTION.
